PH.ETE.1 DECLARATIONS OF INTEREST

Councillor Swinburn, Portfolio Holder for Environment and Transport declared a personal interest in agenda item, PH.ETE.3 relating to tracking item DNPH.ET.16 (Petition for a pedestrian crossing, Station Road, Stallingborough) as a ward councillor who had previous involvement in this matter.

PH.ETE.2 PETITION – ST CHRISTOPHER ‘S ROAD, HUMBERSTON

The Portfolio Holder received a consultation petition in opposition to the proposed introduction of parking restrictions along the western kerb line of St Christopher’s Road, Humberston.

Mrs Newson, the lead petitioner, understood that Humberston Academy had a morale duty to safeguard the students and had concerns for the students’ safety. She gave details of how the scheme under consultation impacted unfairly on 15 residents because it would mean that between 8am – 9am and 3pm - 4pm, residents would be required to move their vehicles and would not be able to park outside their houses in the proposed keep clear area.

Councillor Harness attended the meeting as a ward councillor for Humberston and New Waltham. He explained that he did not associate the residents parking with the problem. He explained there had been no consultation with the parish council until the issue was raised by the petitioner. He felt it would be unfair to comment further until he attended the site visit with officers on the 7th June 2019.

Ms Swatman confirmed that the proposed scheme was at the informal consultation stage and that feedback from residents and the petition would be considered. Consultation with the parish council was an oversight and officers had since given them the opportunity to comment on the proposals. She confirmed the next step was a site visit on 7th June 2019 and, following that visit, officers would review the design. Councillor Swinburn asked for the timescale of the final proposal. Ms Swatman confirmed the work would be scheduled once the final design had been agreed.

RESOLVED – That the consultation petition be received and the lead petitioner be updated on progress.

TRACKING REPORT

The Portfolio Holder received the tracking report tracking the recommendations of this Portfolio Holder.

On the petition around the pedestrian crossing, Station Road, Stallingborough, Ms Swatman confirmed that initial proposals would be going to the parish council meeting for consultation.

On the parking conditions on Bolingbroke Road, Cleethorpes, Ms Swatman confirmed that officers had met with Councillor Brookes and the work had been planned for 2020.

On the petition for parking restrictions for Anderson Street and Earl Street in Grimsby, Ms Swatman confirmed that the schemes had been carried forward and there was a meeting with the ward councillors to go through the findings from the street surveys.

On the petition to close the access between the Spinney and the Lawns, a full report would be prepared and it was expected that it would be submitted to the meeting of this portfolio holder in August 2019, to allow for the decision after the Planning Committee meeting on an influencing factor in July 2019.
