ROAD TRAFFIC REGULATION ACT 1984 (SPECIAL EVENTS) – SECTION 16A
PLATINUM JUBILEE STREET PARTY ROAD CLOSURES – 04 JUNE 2022
(TEMPORARY PROHIBITION OF TRAFFIC – TTRO 22-034D) ORDER 2022

WHEREAS the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Section 16 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 hereby make the following Order the effect of which will be that **no person shall cause or permit** any motor vehicle to **PROCEED** along the below sections of highway:

- LITTLEBECK ROAD, HUMBERSTON – Full extent

Alternative route: CONISTON CRESCENT, A1031 HUMBERSTON ROAD, A1031 CHURCH AVENUE, QUEEN ELIZABETH ROAD

- HURSTLEA DRIVE, HUMBERSTON – Full extent

Alternative route: No diversion available

- PORTLAND AVENUE, GRIMSBY – Part Length from the eastern access road (pedestrian link to PORTLAND PLACE) adjacent to property No. 7 PORTLAND AVENUE in a southerly direction to its intersection with PORTLAND MANOR (PRIVATE ROAD).

Alternative route: No diversion available

- SIGNHILLS AVENUE, CLEETHORPES – Part length from its junction with HARDY’S ROAD to its junction with OXFORD STREET.

Alternative route: OXFORD STREET, CROMWELL ROAD, HARDY’S ROAD

These temporary prohibitions are required to safely facilitate residential street parties in celebration of the Queens Platinum Jubilee.

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation on **Saturday, 04 June 2022** and shall continue for a period of three days unless extended by Order of the Secretary of State for Transport.

Exemptions to the order will be for authorised vehicles only, as listed below.

- Emergency Vehicles (Fire, Police, Ambulance, Coast Guard)
- Authorised Contractors

The Order may be cited as "The North East Lincolnshire Borough Council, Road Traffic Regulation Act 1984 (Special Events) – Section 16A, Platinum Jubilee Street Party Road Closures – 04 JUNE 2022 (Temporary Prohibition Of Traffic – TTRO 22-034D), Order 2022"
