<u>WHEREAS</u> the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Section 16 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 hereby make the following Order the effect of which will be that **no person shall cause or permit** any motor vehicle to **PROCEED** along the below sections of highway:

A section of BEELEY ROAD, GRIMSBY – Part Length from a point adjacent to property No.
 28 BEELEY ROAD to a point adjacent to property No. 82 BEELEY ROAD.

Alternative route: No diversion available

• MINNOW CLOSE, GRIMSBY - Full extent.

Alternative route: No diversion available

 A section of STANLEY STREET, GRIMSBY – Part Length from its junction with ROBERTS STREET to its roundabout junction with ELEANOR STREET / BULLER STREET / HUMBERSTONE ROAD.

Alternative route: ROBERTS STREET, WEELSBY STREET, ELEANOR STREET

BASSETT ROAD, CLEETHORPES – Full extent.
 Alternative route: CROMWELL ROAD, HARDY'S ROAD, DAGGETT ROAD

 A section of CROWHILL AVENUE, CLEETHORPES – Part length from its junction with BOWLING LANE to the north-western extremity of CROWHILL AVENUE.

Alternative route: No diversion available

NORFOLK LANE, CLEETHORPES – The full extent

Alternative route: No diversion available – dead-end road.

TERRINGTON PLACE, CLEETHORPES – The full extent.

Alternative route: No diversion available

ANDREW ROAD, HUMBERSTON – Full extent.

Alternative route: No diversion available

• ST MATTHEW'S ROAD, HUMBERSTON – Full extent.

Alternative route: STEPHEN CRESCENT, ST MARK'S ROAD, ST CHRISTOPHER'S ROAD

 A section of MARGARET STREET, IMMINGHAM – Part Length from its junction with CRAIK HILL AVENUE to its junction with PILGRIM AVENUE.

Alternative route: CRAIK HILL, PRINCESS STREET, PILGRIM AVENUE

These temporary prohibitions are required to safely facilitate residential street parties in celebration of the Queens Platinum Jubilee.

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation on **Sunday, 05 June 2022** and shall continue for a period of three days unless extended by Order of the Secretary of State for Transport.

Exemptions to the order will be for authorised vehicles only, as listed below.

- Emergency Vehicles (Fire, Police, Ambulance, Coast Guard)
- Authorised Contractors
