**2022 SURFACE DRESSING PROGRAMME – VARIOUS LOCATIONS**  
**(TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING – TTRO 22-046)**  
**ORDER 2022**

**WHEREAS** the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 hereby make the following Order the effect of which will be that **no person shall cause or permit** any motor vehicle from **PROCEEDING** along or **STOPPING** on the below sections of highway:

This temporary prohibition is required because works are being or are proposed to be executed on or near the road by Kiely Bros. on behalf of North East Lincolnshire Council. These works are detailed as the 2022 NELC Surface Dressing Programme. Works will be phased in order to minimise disruption to traffic.

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation on **Monday, 06 June 2022** and shall continue for a period of eighteen months unless extended by Order of the Secretary of State for Transport.

Exemptions to the order will be for authorised vehicles only, as listed below.

- Livered Local Authority Vehicles (ENGIE/ NELC)
- Emergency Vehicles (Fire, Police, Ambulance, Coast Guard)
- Authorised Contractors

The Order may be cited as "The North East Lincolnshire Borough Council, Road Traffic Regulation Act 1984 – Section 14(1)(a), 2022 Surface Dressing Programme – Various Locations, (Temporary Prohibition Of Traffic and Stopping – TTRO 22-046), Order 2022"
