2. Subject and details of the matter (to include reasons for the decision)

Supplementary Substance Misuse Treatment & Recovery Funding 2022-2023 - £546,072.00

The allocated funding is to:

- deliver world-class treatment and recovery services rebuild local authority commissioned substance misuse services, improving quality, capacity and outcomes
- rebuild the professional workforce develop and deliver a comprehensive substance misuse workforce strategy
- ensure better integration of services making sure that people's physical and mental health needs are addressed to reduce harm and support recovery
- improve access to accommodation alongside treatment access to quality treatment for everyone sleeping rough, and better support for accessing and maintaining secure and safe housing

- increase referrals into treatment in the criminal justice system specialist drug workers to support treatment requirements as part of community sentences so offenders engage in drug treatment
- keep prisoners engaged in treatment after release improved engagement of people before they leave prison and better continuity of care into the community

#### 3. Decision being taken

- That authority be delegated to the Director of Public Health in consultation with the Portfolio Holder for Heath, Well Being and Adult Social Care to accept the funding from the Office of Health and Disparities (OHID) on behalf of the Council
- 2. That authority be delegated to the Assistant Director Law, Governance and Assets to complete and execute all requisite legal documentation in relation to the matters outlined above.

Yes – Confirmation of the funding was not received until 20<sup>th</sup> June 2022 and the return date for the signed Memorandum of Understanding (MOU) is the 30<sup>th</sup> of June.

#### 5. Anticipated outcome(s)/benefits

The allocated funding is to enable North East Lincolnshire to deliver locally the outcomes outlined in the 10-year drug plan (Delivering a world-class treatment and recovery system) as listed above.

In summary these are to rebuild drug treatment and recovery services, including for young people and offenders, with new commissioning standards to drive transparency and consistency.
