1. Subject and details of the matter (to include reasons for the decision and detail of any previous cabinet decision)

Award of Department for Education funded 'Holiday Activities and Food Programme' Grant to Humberston Park Academy

On 9th March 2022, Cabinet considered a report from the Portfolio Holder for Children and Education seeking approval of the Department for Education Holiday Activities and Food grant of £789,050 to co-ordinate the delivery of free holiday clubs for children in receipt of benefits-related free school meals. 15% of the total grant may be used to fund provision for children not eligible for free school meals, but who are considered 'otherwise vulnerable' such as those with an Education, Health and Care Plan, those with a social worker and those who are in the care of the local authority.

At that meeting, it was resolved that the acceptance of the Department for Education Holiday Activities and Food (HAF) grant of £789,050, be approved. DN. 130.

This decision enables the Council to deliver the Holiday Activities and Food (HAF) programme across the borough, and engage with key partners to co-ordinate planning via a steering group. The decision enables the Council to award funding to eligible organisations in North East Lincolnshire to provide free holiday activities and food clubs for children eligible for, and in receipt of, benefits-related free school meals, and those children who are considered 'otherwise vulnerable'.

The authority received a bid for HAF grant funding from Humberston Park Academy – a special school - in order for the setting to provide a HAF club for four weeks during the school summer holidays in August, 2022, to include all of the 118 children attending the school. The children at the school have an EHCP and/ or are considered 'otherwise vulnerable. The total HAF Grant requested is £128,857.

2. Decision being taken

After careful consideration by the HAF Steering Group Finance Sub-Committee, it is resolved to award a HAF Grant of £128,857 to Humberston Park Academy to provide four weeks of HAF provision over the school summer holidays, August 2022.

3. Anticipated outcome(s)/benefits

The HAF Programme aims to be inclusive of children with SEND. The award of the grant ensures that children and young people attending the Humberston Park Academy, and their families, will be able to take a full and active part in the HAF programme. They will enjoy the health and wellbeing benefits associated with their participation in a range of exciting, fun, creative and physical activities, food education and signposting to other services that the holiday club offers.

4. Details of any alternative options considered and rejected by the officer when making the decision

1. Officers explored alternative HAF providers to ascertain their potential to provide specialist care; medically trained staff; high staffing ratios and specialist equipment for the children. None were found suitable to be able to meet the needs of the children.
