

**THE NORTH EAST LINCOLNSHIRE BOROUGH COUNCIL**  
**ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14(1)(a)**  
**BEACH HOLT LANE, MAIN ROAD AND NOOKING LANE (AYLESBY)**  
**(TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING– TTRO 22-070)**  
**ORDER 2022**

**WHEREAS** the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 hereby make the following Order the effect of which will be:

- a) that **no person shall cause or permit** any motor vehicle, pedestrian or cycle from **PROCEEDING** along or **STOPPING** on the below sections of highway:
- BEACH HOLT LANE – Full extent from its junction with A18 BARTON STREET to its intersection with NOOKING LANE.
  - NOOKING LANE – Full extent from its intersection with BEACH HOLT LANE to its intersection with MAIN ROAD (junction of CHURCH LANE).

Alternative route (reverse route applies): A18 BARTON STREET, A46 GRIMSBY ROAD, GRIMSBY ROAD (LACEBY), HIGH STREET (LACEBY), BUTT LANE

- b) that **no person shall cause or permit** any motor vehicle from **PROCEEDING** along or **STOPPING** on the below sections of highway:
- MAIN ROAD – Full extent from its intersection with NOOKING LANE to its roundabout junction with BUTT LANE / AYLESBY ROAD.

Alternative route (reverse route applies): A18 BARTON STREET, A46 GRIMSBY ROAD, GRIMSBY ROAD (LACEBY), HIGH STREET (LACEBY), BUTT LANE

This temporary prohibition is required because works are being or are proposed to be executed on or near the road by North East Lincolnshire Council. These works are detailed as the implementation of a highway maintenance scheme to install road markings and traffic signs.

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation on **Monday, 15 August 2022** and shall continue for a period of eighteen months unless extended by Order of the Secretary of State for Transport.

Exemptions to the order will be for authorised vehicles only, as listed below.

- Liveried Local Authority Vehicles (EQUANS / NELC)
- Emergency Vehicles (Fire, Police, Ambulance, Coast Guard)
- Authorised Contractors / Utilities / Waste

The Order may be cited as "The North East Lincolnshire Borough Council, Road Traffic Regulation Act 1984 – Section 14(1)(a), Beach Holt Lane, Main Road and Nooking Lane (Aylesby), (Temporary Prohibition Of Traffic – TTRO 22-070), Order 2022"
