**ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14(1)(a)**  
**STATION ROAD, NEW WALTHAM (SEGREGATED SHARED USE CYCLEWAY /**  
**FOOTWAY)**  
**(TEMPORARY PROHIBITION OF TRAFFIC – TTRO 22-115) ORDER 2022**

**WHEREAS** the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 hereby make the following Order the effect of which will be that **no person shall cause or permit** any pedestrian or pedal cycle from **PROCEEDING** along the below sections of highway:

- A section of STATION ROAD (NEW WALTHAM) CYCLEWAY / FOOTWAY – Part Length of the **footway** from a point 50 metres east of the TOLLBAR ROUNDABOUT JUNCTION to a point 150 metres east of the TOLLBAR ROUNDABOUT JUNCTION.

Alternative route: Pedestrians to temporarily share the cycleway element of the shared facility, alongside the works area.

Cyclists must dismount on approach to the works area and not recommence riding until they have passed the end point of the works, to safeguard all road users.

This temporary prohibition is required because works are being or are proposed to be executed on or near the road by Cadent Gas. These works are detailed as gas connection works.

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation on **Monday, 05 September 2022** and shall continue for a period of eighteen months unless extended by Order of the Secretary of State for Transport.

Exemptions to the order will be for authorised vehicles only, as listed below.

- Liveried Local Authority Vehicles (EQUANS / NELC)
- Emergency Vehicles (Fire, Police, Ambulance, Coast Guard)
- Authorised Contractors

The Order may be cited as "The North East Lincolnshire Borough Council, Road Traffic Regulation Act 1984 – Section 14(1)(a), Station Road, New Waltham (Segregated Shared Use Cycleway / Footway), (Temporary Prohibition Of Traffic – TTRO 22-115), Order 2022"
