

THE NORTH EAST LINCOLNSHIRE BOROUGH COUNCIL
ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14(1)(a)
WELLOWGATE, GRIMSBY
(TEMPORARY PROHIBITION OF TRAFFIC – TTRO 22-051) ORDER 2022

WHEREAS the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 hereby make the following Order the effect of which will be that **no person shall cause or permit** any motor vehicle, pedestrian or pedal cycle from **PROCEEDING** along the following sections of highway on the dates detailed below:

Monday 12th September to Friday 14th October 2022 – 24hr Road Closure

- A section of WELLOWGATE, GRIMSBY – Part Length from its junction with BRIGHOWGATE to its junction with ABBEY ROAD.

Thursday 13th October to Friday 14th October 2022 – 24hr Road Closure

- A section of WELLOWGATE, GRIMSBY – Part Length from its junction with CHURCH LANE / BETHLEHEM STREET to its junction with WELLOWGATE / intersection with BRIGHOWGATE.

Alternative route: ABBEY ROAD, GARDEN STREET, ABBEY WALK, OSBORNE STREET, BETHLEHEM STREET

This temporary prohibition is required because works are being or are proposed to be executed on or near the road by North East Lincolnshire Council. These works are detailed as footway and carriageway reconstruction.

Works will be undertaken in phases to limit disruption to pedestrian access.

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation on **Monday, 12 September 2022** and shall continue for a period of eighteen months unless extended by Order of the Secretary of State for Transport.

Exemptions to the order will be for authorised vehicles only, as listed below.

- Liveried Local Authority Vehicles (EQUANS / NELC)
- Emergency Vehicles (Fire, Police, Ambulance, Coast Guard)
- Authorised Contractors

The Order may be cited as "The North East Lincolnshire Borough Council, Road Traffic Regulation Act 1984 – Section 14(1)(a), Wellowgate, Grimsby, (Temporary Prohibition Of Traffic – TTRO 22-051), Order 2022"
