

**THE NORTH EAST LINCOLNSHIRE BOROUGH COUNCIL**  
**ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14(1)(a)**  
**A1136 GREAT COATES ROAD, GRIMSBY**  
**(TEMPORARY PROHIBITION OF TRAFFIC – TTRO 22-127) ORDER 2022**

**WHEREAS** the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 hereby make the following Order the effect of which will be that **no person shall cause or permit** any motor vehicle from **PROCEEDING** along the below sections of highway:

- A section of GREAT COATES ROAD – Part Length from its roundabout junction with LITTLECOATES ROAD / YARBOROUGH ROAD to its junction with WYBERS WAY / LAMOUR ROAD.

Alternative route: YARBOROUGH ROAD, CROMWELL ROAD, WINGATE ROAD, LAMOUR ROAD

This temporary prohibition is required because works are being or are proposed to be executed on or near the road by North East Lincolnshire Council. These works are detailed as removal of a traffic island and carriageway resurfacing.

Works will be undertaken in two phases as follows:

**PHASE 1: Monday 10<sup>th</sup> October 2022 to Tuesday 11<sup>th</sup> October 2022 (19:00hrs to 06:00hrs) – Removal of traffic island**

**PHASE 2: Monday 21<sup>st</sup> November 2022 to Friday 02<sup>nd</sup> December 2022 (19:00hrs to 06:00hrs daily) – Carriageway resurfacing**

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation on **Monday, 10 October 2022** and shall continue for a period of eighteen months unless extended by Order of the Secretary of State for Transport.

Exemptions to the order will be for authorised vehicles only, as listed below.

- Livered Local Authority Vehicles (EQUANS / NELC)
- Emergency Vehicles (Fire, Police, Ambulance, Coast Guard)
- Authorised Contractors

The Order may be cited as "The North East Lincolnshire Borough Council, Road Traffic Regulation Act 1984 – Section 14(1)(a), A1136 Great Coates Road, Grmsby, (Temporary Prohibition Of Traffic – TTRO 22-127), Order 2022"
