REMEMBRANCE PARADE – THE AVENUE, LOW ROAD AND OAK ROAD
(HEALING)
(TEMPORARY PROHIBITION OF TRAFFIC – TTRO 22-147) ORDER 2022

WHEREAS the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Section 16 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 hereby make the following Order the effect of which will be that **no person shall cause or permit** any motor vehicle or cycle to **PROCEED** along the below sections of carriageway between 08:00hrs and 14:00hrs on **SUNDAY 13TH NOVEMBER 2022**. The extent of the closure will be:

THE AVENUE – Part length, from its junction with RADCLIFFE ROAD to its junction with LOW ROAD

LOW ROAD – Part length, from its junction with STALLINGBOROUGH ROAD to its roundabout junction with STATION ROAD.

OAK ROAD – Part length, from The British Legion to its junction with THE AVENUE.

Alternative route: WISTERIA DRIVE, STATION ROAD

Adjoining streets may be affected for a short period of time whilst the Parade passes but will be reopened as soon as it is safe to do so.

This temporary prohibition is required to allow safe facilitation of the Remembrance Day Service at the Cenotaph on Low Road and associated Parade from The British Legion.

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation on **Sunday, 13 November 2022** and shall continue for a period of three days unless extended by Order of the Secretary of State for Transport.

Exemptions to the order will be for authorised vehicles only, as listed below.

- Emergency Vehicles (Fire, Police, Ambulance, Coast Guard)
- Authorised Contractors

The Order may be cited as "The North East Lincolnshire Borough Council, Road Traffic Regulation Act 1984 (Special Events) – Section 16A, Remembrance Parade – The Avenue, Low Road and Oak Road (Healing) (Temporary Prohibition of Traffic – TTRO 22-147), Order 2022"
