Humberside Police seek a review of this Premises Licence as during a joint visit with ourselves and Immigration to the premises on 23/11/21 & 08/09/22, it was found that an illegal worker was on the premises and employed at the premises. There were no further persons present at the location that could have been working, and it was the same person without permission working at the premises on each occasion.

A Civil Penalty was subsequently issued to the Premises Licence Holder in relation to the illegal worker being found at the premises in November, and it is believed a second fine would be issued by Immigration for the repeated offence

Immigration offences, including Civil Penalties, are a clear breach of the Crime and Disorder Licensing Objective.

Section 36 and Schedule 4 of the Immigration Act 2016 (the 2016 Act) amended the Licensing Act 2003 (the 2003 Act) to introduce immigration safeguards in respect of licensing applications made in England and Wales on or after 6 April 2017.
