

THE NORTH EAST LINCOLNSHIRE BOROUGH COUNCIL
ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14(1)(a)
WILLINGHAM STREET, GRIMSBY
(TEMPORARY PROHIBITION OF TRAFFIC & TEMPORARY SUSPENSION OF
ONE-WAY TRAFFIC – TTRO 22-151) ORDER 2022

WHEREAS the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 hereby make the following Order the effect of which will be that:

a) **no person shall cause or permit** any motor vehicle, pedestrian or cycle from **PROCEEDING** along the below sections of highway:

- A section of WILLINGHAM STREET - Part Length from its junction with MALLARD MEWS to its junction with WINTRINGHAM ROAD.

Alternative route: CATHERINE STREET, HAINTON AVENUE, WELHOLME ROAD, WILLINGHAM STREET

b) that the permanent one-way traffic restriction along the below sections of highway is **temporarily suspended** and the length of carriageway reverted to two-way traffic flow, to enable access for local residents:

- A section of WILLINGHAM STREET – Part Length from its junction with CATHERINE STREET to its junction with MALLARD MEWS.

This temporary prohibition is required because works are being or are proposed to be executed on or near the road by Anglian Water. These works are detailed as the installation of a new water connection

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation on **Wednesday, 07 December 2022** and shall continue for a period of eighteen months unless extended by Order of the Secretary of State for Transport.

Exemptions to the order will be for authorised vehicles only, as listed below.

- Emergency Vehicles (Fire, Police, Ambulance, Coast Guard)
- Authorised Contractors / Utilities / Waste

The Order may be cited as "The North East Lincolnshire Borough Council, Road Traffic Regulation Act 1984 – Section 14(1)(a), Willingham Street, Grimsby, (Temporary Prohibition Of Traffic & Temporary Suspension of One-Way Traffic – TTRO 22-151), Order 2022"
