<p>03/23</p>	<p>Funding Formula for Schools 2023-24 Update</p> <p align="center">  SCHOOLS FORUM REPORT 130123 ITEM </p> <p>The original Modelling work was done using October 2021 census data; it was expected the financial position would change once the updated census information FPR October 2022 had been received. On the 20th of December 2022 the DfE issued the final funding allocation for the 2023-24 financial year together with a revised APT updated for the October 2022 School census data. The revised report is attached, and a full update was discussed & reviewed by the attendees.</p>

05/23	<p>Delivering Better Value</p> <p> DBV Presentation to Schools forum 13th Jc</p> <p>The attached slide deck was reviewed by the meeting; RT gave a detailed overview of the presentation. The headlines were as follows:</p> <ul style="list-style-type: none"> • The Department for Education (DFE) is committed to improving the outcomes for children and young people with SEND. It commissioned the Delivering Better Value (DBV) programme to support 55 Local Authorities (LAs) to identify local and national opportunities to improve the outcomes for CYP with SEND and create robust implementation plans that LAs can follow to deliver on these ambitions. • The DBV programme is designing its support through 2 key approaches through Short Term Help and informing long term reform and is divided into different Phases • NELC has developed 3 modules critical to ensure identification of sustainable changes that will drive high quality outcomes for CYP, and support in the development of the grant application. • Modules 1 & 2 have been completed whilst module 3 is work in progress. <p>Next Steps:</p> <ul style="list-style-type: none"> • 2 x Workshops to take place; all settings to be invited in order to discuss the results in more detail; gather input and feedback on ideas for how the funding might be used and insist all settings to send a representative • An Internal piece of work to check what else is happening across Children’s Services, so that the grant funding can be maximised. <p>RT confirmed a more detailed update can be provided once all the results are back</p>
