As far as I understand the application, it was submitted during the Fitties closed season. This means I was limited to a delay in being informed as well as been able to respond to the application.

The operating hours of 0800 to 23.30 everyday seems excessive and the possibility of potential noise throughout these hours I feel will be detrimental to the way of life I want to experience on Fitties. Peace and tranquility! Being able to listen to wildlife not recorded music.

I am already concerned with the existing nuisance noise from Thorpe Park without this extra noise going ahead.

Should there be details of the occupancy capacity? As the more people the more noise. Surely there needs to be some sort of control on numbers

Paragraph 9.4.2 states the Licensing Authority intends to interpret “public nuisance” in its widest sense, and takes it to include such issues as noise, light, odour, litter and anti-social behaviour, where these matters impact on those living, working or otherwise engaged in normal activity in an area. How can the Licensing Authority ensure this?

The sound from the outdoor activity area and sound stage that was built in contravention of the planning conditions already creates a noise impact for me as a Fitties resident. Does the licensing application consider the combined effects of noise as they are adjacent to each other. I would like to see a noise impact assessment undertaken by the council to consider this cumulative effect of noise before the license is considered. I have seen no details on the design or layout of this temporary show bar which has already been installed. If a planning enforcement case is currently open for this temporary show bar surely no license should be given.

I am extremely concerned about this application as I feel it is detrimental to the peaceful, and conservation aspect which is the Fitties. This application would affect the wildlife that Fitties is known for as well the people who live there. I think the application should not be granted.

If possible please suggest alterations to the application that would resolve the problem mentioned above, again paying attention to the licensing objectives: The hours of 8.00 to 23.30 are excessive and could be reduced. But this does not resolve the problem mentioned above. I still think the application should not be granted even with a reduction of hours.

Prevention of public nuisance: Yet another build it first then hope thwy can use it without planning or consideration for neighbours. As per paragraph 9.4.1 in the NELC Statement of Licensing Policy, you do not have a noise assessment. How can you pass this?

Paragraph 9.4.2 states the Licensing Authority intends to interpret “public nuisance” in its widest sense. There is no planning approval for the build, no noise assessment or any idea of impact on neighbouring properties. How can you pass this?

There is already a stage with giant speakers and screen built without planning and awaiting retrospective approval. Givdn the noise bkasted out when in use last year, this licensing application should be considered for the combined effects of noise as they are next to each other. A noise impact assessment MUST be undertaken by the council to consider this cumulative effect before the license is considered.
We cannot endure even more noise than we were illegally subjected to last year.

Once again, thorpre park have chosen to apply for approval to ruin their neighbours lives when those same neighbours are not even allowed to be on site during Jan / Feb. Cyncnical at best.

So, yet another illegally built structure, open early till late serving you dont know how many, With an unknown noise impact on the Fitties to sit alongside the other illegally built structure. We urge you to be strong, refuse this application, ensure its not used AND the structure is taken down.

We could hear it inside with the windows shut and in the summer heat too. It was horrendous.

The noise affected the whole of Humberston Fitties including the local beach.

Sadly the wildlife in our garden simply disappeared.

It is going to be way too close to our properties to be allowed and the hours of operation are unreasonable.

I let my property to holidaymakers who expect a quiet holiday.

They bring their elderly relatives and young children.

It will be a huge nuisance to them and spoil their enjoyment of their break on The Fitties.

It will be the holiday from hell and consequently I will be getting bad reviews and complaints.

The hours they want to operate this noise nuisance is quite unbelievable. All day from early morning to late into the evening, really???

This is a massive threat to this beautiful area and should be rejected.

Prevention of public nuisance: I strongly object to this application. My chalet is directly opposite this ‘proposed amenity’ and I get the full impact of all the extra noise that this temporary stage and bar will produce. The resultant noise from the illegally built outdoor stage has still not been resolved so how can additional performances of music etc be allowed. To have noise from 9am to 11 pm every day will be intolerable. But that is not where the noise ends, at the end of the evening staff empty waste, bottles etc into metal bins which are situated at the rear of the complex and immediately in front of Anthony’s Bank Road and the chalets. These are then often collected around 4am again being dropped from some height into metal bin lorries. Humberston Fitties is not a noisy holiday park but a quiet haven for people and the many different sorts of wildlife which we all enjoy. It is a conservation area and needs to be conserved. There are no details as to how big this temporary building is or how many people it will cater for. Built without planning

All addition and original noise and nuisance levels should be addressed and sorted out before licensing approval, not afterwards.

The ability to be onside to sit and enjoy the quiet and peaceful surroundings is essential to everyone’s mental health. The Fitties chalets were built long before Thorpe Park.

If possible please suggest alterations to the application that would resolve the problem mentioned above, again paying attention to the licensing objectives: The temporary stage should be sited well away from its present site and a definite reduction in the operating hours. All day every day is certainly not acceptable.

Prevention of public nuisance: No planning permission has been sought for the building (now in situ) for which the licence is being applied. The building will be used until the end of the season which is far longer than 28days.

Background - Thorpe Park are already in breach of planning permission with the original show bar - they have flouted the permission received by building the bar in a different position to that agreed. This makes a mockery of NELC Planning Committee. With this in mind, plus the fact that they have not applied for planning permission for the new 'temporary' show bar makes Thorpe Park licence application a farce!

Also, the noise already coming from the 'breached planning' show bar is unacceptable, another bar would make life even more unbearable for neighbours. There is no longer any more quiet enjoyment of life for the Fitties or other Humberston homeowners.

The noise impacts on the SSSI Humber Estuary and also encroached on the 500m buffer zone thus affecting wildlife both indigenous and migrants.

Thorpe Park visitors bring nothing into the local economy, Thorpe park reaps the benefits by keeping guests within their boundaries. There is no benefit whatsoever to the local area. The bar will cause a nuisance with noise pollution for the best part of 24/7.

We are the 'little people' but we are no less important than big money making machines such as Thorpe Park. We are your council tax payers, we need you to work on our behalf, to stop all the anti social behaviour ie noise etc which will no doubt come if this licence is granted.

It is proposed this will grant permission for Films, Live Music, Recorded Music, Performance of Dance, Entertainment of a like Kind, all outdoors Monday to Sunday 0900 until 2200 hours' on the grounds of 'Prevention of Public Nuisance'.

Thorpe Park and the Fitties have coexisted for many years each offering a different experience. My objection is not meant to spoil anyone's enjoyment but is made to ask Thorpe Park to be considerate neighbours and understand how intrusive and upsetting loud music and associated noise nuisance can become.

Results from studies suggest neighbour noise annoyance to be significantly associated with eight different physical and mental health symptoms such as pain in various body parts, headache, fatigue, depression and anxiety.

During the 2022 season owners of chalets on the adjacent Fitties experienced unacceptable levels of noise nuisance from the recently erected sound stage. This greatly interfered with what I understand to be termed 'use or enjoyment of their property'. Even once the music had stopped for the evening the sound of clear up operations continued well into the night. Requests made to Thorpe Park management to reduce both volume and duration of the music were ignored.

Thorpe Park has thrived and expanded over many years without the need for constant Ibiza / Ayia Napa style outdoor music. Many chalets are owned by people who enjoyed the old school neighbourly charm and peace and quiet the Fitties offer but now feel this has been wrenched away. I therefore believe a licence for every day from 9am until 10pm is excessive and constitutes a loss of amenity and a right to quiet enjoyment for Fitties chalet owners; especially those closest to the Showbar / Sound Stage. I would propose as a compromise the New Premises Licence be restricted to Fridays and Saturdays, mid-day until 22:00 only.

Namely 13 to 14 hours of intolerable noise per day, 7 days a week from loudspeakers and associated crowd noise.

9.4.2 - Defines public nuisance as 'noise, light, odour, litter and anti-social behaviour, where these matters impact on those living, working or otherwise engaged in normal activity in an area.' 

Prevention of public nuisance: Thorpe park has submitted a licence application to NELC for a NEW ‘Temporary Showbar with stage. This license application should not be heard or considered until all Thorpe Park Planning breeches have been rectified. Failure to not, will send message from council to all that it is ok to breech planning and try to circumnavigate planning regulations.

They have already built this temporary showbar stage and bar without any planning permission (see photo) and NELC planning have advised as of this date it is being investigated by NELC enforcement team.

Thorpe Park also breeched planning for the outdoor activities. Moving ALL the nosiest activists towards and directly facing into the designated Humberston Fitties. This license to allow another stage and bar next to it should not be allowed. This is impacting on the Conservation and protected SSSI area. The retrospective planning for this has still to be decided and if this license allowed you will be doubling the nuisance noise being inflicted onto Humberston Fitties residents and wildlife.

Licensing must give full consideration to the implications of a license e.g. impact on amenity by allowing loud recorded music, live music, sporting events, films on homeowners given the close proximity to neighbouring properties in Humberston Fitties. The licensing board must consider in FULL the implications, given that these very properties (listed on HER and under of Article 4 directive and the associated design guide imposed by NELC resulting in properties non standard design and do not have the same sound mitigation that standard properties have.

Why are Thorpe Park placing all the nosiest activity in the closest proximity possible to the protected SSSI and conservation area renowned for peace, tranquillity and nature, especially given the vast amount of land Thorpe Park have available? Absolutely no consideration being shown to people outside the park.

Prevention of public nuisance: I object to this license application and request that the licensing department and licensing subcommittee do not approve this application.

I would like it to be noted that as part of my representation, I do not object to the existence of Havan Thorpe Park, nor do I object to Thorpe Park looking at developing ways to offer an improved holiday experience to their guests. My representation regarding this license application is that I object to the creation of new environmental impacts, in particular noise, which are created by Thorpe Park, should be contained within the boundaries of Thorpe Park.

Summary of representation and objections to this license application are as follows:

1. Protecting my own amenity relating to licensing objective 3. The prevention of public nuisance relating to noise.

2. Protecting the amenities of other neighbours in Humberston and the Humberston Fitties Conservation area relating to licensing objective 3. The prevention of public nuisance relating to noise.

2. Protecting the local environment - The Humberston Fitties area is important both nationally and internationally and includes designated SSSI/SPA/SAC/Ramsar site/Conservation area, plotland area and LWR.

This license application is for the creation of an entertainment facility of significant size with potential to create a new source of nuisance noise when considered both as a standalone facility but also as a contributing factor to a cumulative source of nuisance noise when combined with the new sprawling high adrenaline outdoor entertainment area introduced in 2022. In addition to the direct noise created by this potential temporary show bar, consideration should also be given to the overall increase in crowd noise created by the increased numbers of people using these facilities.

The license application includes some brief notes relating to license objective d. prevention of public nuisance. It suggests the applicant will have a written noise management plan in place. There is no reference to a full noise assessment. Given the recent developments within Thorpe Park which have contributed to noise nuisance and breaches of planning conditions, it is surprising to see that neither the noise management plan nor a noise impact assessment have been submitted or requested as part of this license application. This could indicate the applicant is not learning from the errors of their ways and the detrimental impact they have created for their neighbours and sensitive protected natural environments.

This license for a new Temporary Show bar is being applied for while the current outdoor entertainment complex, introduced by Thorpe Park in 2022 does not have planning consent agreed, and is subject to enforcement action due to multiple breaches of planning conditions (DM/0527/22/FUL). I recognise that license applications are considered on a case-by-case basis, however the local authority should consider this application, in conjunction with all other planning and licensing applications made by the applicant relating to entertainment on the basis:

1. The location of the proposed Temporary Show bar is located within the park's entertainment complex and adjacent to new facilities introduced in 2022 which have no valid planning application in place, breached original planning conditions and is subject to multiple interventions by the NELC enforcement team.
2. The location of this show bar further expands the current entertainment area, which is subject to enforcement activity and has no current planning consent in place.
3. A recent license variation regarding the redevelopment and expansion of the applicant's current indoor show bar has forced the applicant to make many significant changes to its show bar design and operation to reduce noise nuisance impacts. The changes were only made following public representation and conditions imposed by the NELC licensing subcommittee.

This new license application has been submitted without any planning application and as such, no design has been submitted that shows any materials or measures being applied to prevent noise nuisance (not just mitigate after implementation)

4. This license application indicates the application would like the proposed temporary show bar to be in place from ASAP to 31st October 2023. At a recent Licensing Sub Committee relating to a license variation for the current indoor show bar, the applicant indicated that work for their permanent show bar will be complete in May / June.

Applying the balance of probability.

When reviewing this license application and the view of those submitting representations and objections, the balance of probability will be applied. I do not believe, for the purpose of this application, the balance of probability should be found in favor of the applicant as:

1. At the time of writing this representation, and prior to any licensing or planning applications being agreed, the applicant has progressed significantly with building the new temporary show bar. The progress I cannot confirm, however there is now a significant structure in place, on the position indicated on the map provided as part of this license application.
2. At the time of writing this representation, my understanding that the structure that has been built is subject to a planning enforcement investigation.
3. The applicant failed to produce a noise impact assessment in advance of implementing its new outdoor entertainment area.
4. The applicant failed to produce a noise management plan before implementing its new outdoor entertainment area.
5. The applicant has breached planning conditions relating to its new outdoor entertainment area.
6. The applicant has been subject to multiple enforcement actions since implementation of its new entertainment area.
7. The applicant has needed to submit a retrospective planning application for its outdoor

entertainment area due to breaches in planning conditions and public objection relating to noise nuisance.

8. The applicants retrospective planning application for its new entertainment area is pending and as such this application for additional licensed activity should not be considered.

9. The applicant has further breached planning conditions relating to the refurbishment and extension of its current show bar. The application was approved subject to a condition that construction works will not commence prior to 08:00. This condition has been breached on multiple occasions.

10. The applicants' recent license variation relating to the current indoor show bar has seen multiple revisions to the design of the show bar and licensing conditions applied following public representation and objection. This could suggest the applicant's capacity to consider the needs of its neighbours and its shared borders with sensitive natural environments are not being considered proactively or properly.

11. The applicant has asked for the temporary show bar to run from ASAP to 31st October 2023. The applicant knows that they will complete works on their current indoor show bar in May / June 2023. Why would they want or need to show bars running concurrently? If the applicant knows they will complete works on their current indoor show bar in May / June 2023, why are they requesting the additional temporary show bar to be licensed to operate for an additional 5 months past this completion date?

Questions for NELC Licensing Team and Licensing Sub Committee

1. Why is this application being considered without planning permission?

2. Why is the 28-day maximum for an outdoor entertainment venue being applied

3. The license application states the temporary show bar will operate ASAP until 31st October 2023. The applicant, at a recent License hearing indicated works associated with the refurbishment and extension of the current indoor show bar will be completed by May / June 2023

4. This license application is a further extension to the Thorpe Park entertainment complex. As part of reviewing this license application and in advance of a potential licensing hearing, it is requested all licensing committee members visit the Thorpe Park entertainment complex including the rear service area of the complex and closest existing sensitive receptors / neighbours bordering the entertainment complex.

5. How does NELC define 'temporary' when considering license application for temporary premises with such a significant size, potential for public nuisance (noise) and operating times (7 days per week, 14 hours a day for up to 8 months)

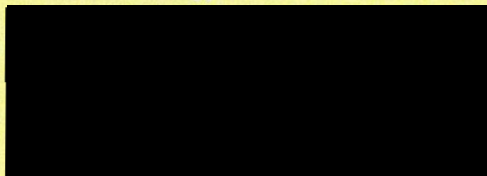

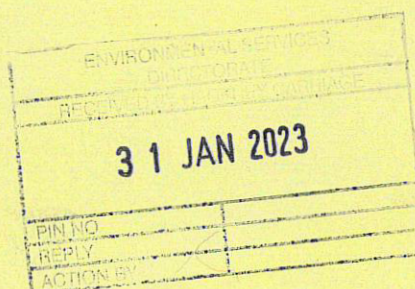

Prevention of public nuisance: Unacceptable levels of noise constituting a public nuisance from these premises from this and other licenced areas.

The issuing of previous and associated licences to this applicant has resulted in a breach of the general duties of the licensing authority as they have failed to prevent public nuisance.

The company has breached previous licence conditions and planning conditions operating without planning permission creating a statutory nuisance for a period of 7 Months.

Again Thorpe Park have erected a structure directly related to this licence application (Temporary Showbar) without planning permission and an enforcement notice has been raised by NELC to register this breach of planning law.

Both Thorpe Park and the NELC Environmental Team have failed to monitor and control noise from Thorpe park to prevent public nuisance

Over 250 written complaints regarding noise, nuisance, and loss of amenity received by the council in relation to this applicant's activities.

This licence application if approved will further increase activity, noise and disturbance to residents.

Paragraph 9.4.2 of the NELC Licensing Police states it intends to interpret public nuisance in the widest sense including noise, light, odour, litter and anti social behaviour.

Excessive noise causing a significant change to the noise environment resulting in a loss of amenity to residents and occupiers of the holiday park alike.

At what point will NELC both licensing and planning stand up to this corporate bullying and protect residents from the harm they are causing to a local community and carry out their duty to prevent public nuisance.

The cumulative impact of the Temporary Showbar, outdoor stage and marina bar will lead to intrusive levels of noise which will cause a public nuisance.

If the council fail again to protect residents again then formal complaints to the Local Government Ombudsmen will be issued.

No details of occupancy capacity have been provided

The hours of operation are unacceptable and would not be allowed on a 7 day a week basis at any other outdoor venue in Grimsby or Cleethorpes.

There are currently no controls to prevent general members of the public including minors entering the various outdoor entertainment areas and bar facilities at Thorpe Park again a potential child protection issue.

Showing Films outdoors have been a significant source of complaints resulting in short loud bursts

of sound exceeding 74 dB at local residents properties.
No noise assessment has been produced for this venue.

If possible please suggest alterations to the application that would resolve the problem mentioned above, again paying attention to the licensing objectives: Licensing hours for entertainment should be significantly reduced to be 11.00 am to 20.00 pm to prevent disturbance to families with children both on Thorpe Park and Humberston Fitties.

The sound system should have a restricted controller installed that is check and approved by NELC Environmental team in consultation with residents with levels set by carrying out sound tests with all venues operating and sound levels recorded at Humberston Fitties Conservation area residents properties.

The walls of the temporary showbar should not be allowed at any time to prevent excessive noise entering the acoustic environment.

Checking of accredited proof of age cards should be required to enter all venues serving alcohol.

Employment of adequate security to prevent the general public increasing numbers and increase the likelihood of public disorder.

Due to the outdoor nature of the venue no lasers or light shows should be allowed again to prevent public nuisance.

No films or separate PA systems should be allowed as these are less controllable and deliver sound at a much higher frequency (intensity)

Prevention of public nuisance: One of the stated responsibilities of the licensing authority is to ensure it maintains and protects the amenity of residents and other businesses from the potential consequence of the operation of the licensed premises. The NELC licensing policy also states the Licensing Authority intends to interpret “public nuisance” in its widest sense, and takes it to include such issues as noise, light, odour, litter and anti-social behaviour, where these matters impact on those living, working or otherwise engaged in normal activity in an area. How can the LA achieve this when there are very little details on what this temporary showbar constitutes? There is a vague statement that “measures shall include but not be limited to the layout of the temporary Showbar including the location and direction of any speaker systems, type of noise monitoring and a procedure for investigating noise complaints”. All of these things should be submitted prior to the hearing so the LA can meet its objectives and members of the public can also scrutinise the details.

The applicant also states that there will be a noise management report and a sound limiter in place agreed with NELC environmental protection prior to first use. This is what was put in place for the current outdoor stage and activity area which created a significant loss of amenity to Fitties residents last year, so these measures are flawed and once again should be submitted prior to the hearing for scrutiny. There is also no account taken for crowd noise
This license application should not be viewed in isolation.

This temporary showbar is adjacent to the existing soundstage and activity area and there are no details provided on how this temporary showbar will operate in parallel with the soundstage and activity area. Any additional noise impact assessment must include all sources of noise, without this the LA cannot meet its objective on public nuisance.

The temporary showbar has already been erected and no planning application has been submitted. NELC planning enforcement have opened a case to look at this. This enforcement case must be concluded before the LA makes a determination on this license application.

Prevention of public nuisance: We currently experience disturbance from the facilities, our properties are within metres of the area/premises, the planned application if granted will severely impact the area, with noise, light pollution and anti-social behaviour. Serving alcohol from 9am to 10pm daily is very concerning it could surely lead to excessive consumption and subsequent problems for all.

There is no screening between the boundaries which will provide any form of insulation from increased noise. Our properties are chalets, with no sound insulation and in accordance with the terms of our lease we are unable to change our chalets to ease the problem. Music from 9 am daily even at a background level will impact on our lives and the local wildlife.

We as owners on the Humberston Fitties must abide by park rules set by Tingdene (Owned by Bourne Leisure) with no loud music, parties or do anything that will spoil the enjoyment of other residents – we are having our enjoyment spoilt by Thorpe Park!

The Humberston Fitties is a Conservation Area, with many different Species of birds and wildlife – the operating hours will severely impact on the area with noise, light pollution. No forgetting we are adjacent to an SSSI area. Bourne Leisure/RSK Acoustics impact assessment appears to have drawn the conclusion it will be negligible - having experienced the noise from base/drums last year, I for one certainly dread what we owners on the Fitties/Anthonys Bank will experience if the license is granted.

Prevention of public nuisance: The cumulative noise impact of this and other noisy elements of Thorpe Park’s activities around the existing show bar, outdoor stage and mariners bar will further add to the loss of amenity to my property nearby that results in regular complaints about a noise nuisance.

Those complaints rarely come to anything because Thorpe park are always the first recipient of my complaints (and many others) and generally act quickly to reduce the noise once I have threatened to contact NELC and licensing authorities.

They unfortunately don’t always respond positively.

I’m not always there to complain, nor do I enjoy doing so, but Thorpe park and NELC regularly receive these complaints and frequent I’ve been asked to complete a diary, of which Thorpe park are always aware, so they make a point of avoiding further recordable noises for the time being. This has the effect that the diary looks pretty pointless to those filling it in, leaving little enthusiasm for following it up by submitting the diary to NELC, because it makes the complaint look pretty ludicrous to have made the complaint in the first place.

This is true of 99% of cases, so little is ever done about it.

If however the council were to accept that it’s not in human nature to complain when being subjected to a noise nuisance, and to accept that the complaints are ALL likely to be well justified without a diary being necessary, then the opportunity to react positively to a noise nuisance exists and should be followed up with license withdrawals, because there are literally hundreds of complaints about Thorpe park’s noisy activities some years, none of which are ever followed up for the reasons given above.

It appears to all complainants that the council don’t care about the noise impact on the amenity of Fitties chalet owners who sought to enjoy peace and tranquility at their chalets, but get ignored by the council whenever they complained about the noise impact on their lives.

My own activity has changed because of the noise Thorpe park make, in that during the peak season, I tend to avoid being at my chalet because of the noise, and if I am there I avoid being outside in the evening.

I’m also preparing to sell my chalet due the noise problem, as are many.

It will soon revert to waste land thanks to Thorpe park and their friends at NELC.

If possible please suggest alterations to the application that would resolve the problem mentioned above, again paying attention to the licensing objectives: If these activities cannot be relocated to another part of their huge site, away from the peaceful environment of The Fitties, the noise escaping from the site should be contained with sound absorbing structures at Thorpe park’s expense.
