THE NORTH EAST LINCOLNSHIRE BOROUGH COUNCIL ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14(1)(a) FAIRFIELD ROAD, SCARTHO (TEMPORARY PROHIBITION OF TRAFFIC – TTRO 22-180) ORDER 2023

<u>WHEREAS</u> the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 hereby make the following Order the effect of which will be that **no person shall cause or permit** any motor vehicle from **PROCEEDING** along the below sections of highway:

A section of FAIRFIELD ROAD – Part Length from its junction with BULWICK AVENUE to a
point 75 metres south-west of its junction with BULWICK AVENUE.

Alternative route: FAIRFIELD ROAD, B1203 WALTHAM ROAD, SPRINGFIELD ROAD, LAVENHAM ROAD, CONISTON AVENUE, THIRLMERE AVENUE (reverse route applies)

This temporary prohibition is required because works are being or are proposed to be executed on or near the road by Freedom Group. These works are detailed as the use of a crane in the carriageway to deliver and subsequent recovery of electrical equipment to / from the adjacent substation.

An initial road closure will take place on **Tuesday 14th March 2023** for the delivery of the equipment, once complete the road will be reopened. A further road closure will then be implemented on **Friday 17th March 2023** to enable the equipment to be retrieved. Both closures are expected to take place between the hours of **8am and 4pm**.

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation on **Tuesday**, **14 March 2023** and shall continue for a period of eighteen months unless extended by Order of the Secretary of State for Transport.

Exemptions to the order will be for authorised vehicles only, as listed below.

- Liveried Local Authority Vehicles (EQUANS / NELC)
- Emergency Vehicles (Fire, Police, Ambulance, Coast Guard)
- Authorised Contractors / Waste

The Order may be cited as "The North East Lincolnshire Borough Council, Road Traffic Regulation Act 1984 – Section 14(1)(a), Fairfield Road, Scartho, (Temporary Prohibition Of Traffic – TTRO 22-180), Order 2023"
