

#### DM/0470/23/FUL – removal of condition 5 (northern buffer zone); Land at Field Head Road, Laceby

The above planning application was discussed at the Parish Council Meeting on the 6<sup>th</sup> June 2023.

In consideration of the plans which were reviewed and the representations made by many residents at the Parish Council Full Planning and Finance Meeting, Laceby Parish Council object to the removal of this condition and request that NELC refuse this application.

The current buffer zone was put in place when the 400m was removed, and was done so in order to protect the residents of the new houses on the Land at Field Head Road, and enable the piggery to continue with its practice.

If the developer is given approval for the buffer zone to be removed, they are looking to build bigger houses in place of the current (approved) ones with the buffer zone in place. These houses border the piggery, and when there are no crops in the field the farmer does muck spread across the field behind these houses and along the hedgerow and this will adversely affect the residents of these properties and the piggery. The supporting documentation considered the impact when there were crops in the field.

It is not acceptable to have an application with conditions to then look to remove conditions after building has begun.

To protect new residents, existing residents and the piggery, the buffer zone needs to remain in place.

#### **5** Condition

The scheme of landscaping, tree planting and footpath surfacing shown on plans ref. LMP-060521-00 Landscape master plan LP-060521-01 landscape plan 1/3, LP-060521-02 landscape plan 2/3, LP-060521-03 landscape plan 3/3 and RD4598-03G shall be completed within a period of 12 months, beginning with the date on which development began or within such longer period as may be first agreed in writing by the Local Planning Authority. All planting shall be maintained in accordance with the Landscape Management Plan.

Reason To ensure a satisfactory appearance and setting for the development and continued maintenance of the approved landscaping in the interests of local amenity in accordance with Policy 43 of the North East Lincolnshire Local Plan 2013-2032 (adopted 2018).

Of particular interest was DM/0522/21/REM, a "LANDSCAPE PLAN 1" was supplied that showed there would be a Woodland Buffer Planting scheme on the northern boundary consisting of Upper and Lower Woodland Species of trees, plus 2 English Oaks, 3 Field Maples, 2 Silver Birches, 2 Rowan, and 3 Bird Cherries. Woodland Buffers provide a wildlife corridor and can also help reduce the impact of flooding.

As to DM/1133/17/OUT, the updated Odour Assessment does not appear to consider the impact the removal of the buffer zone would have on the farmer or future residents living nearby should there be an increase in the number of livestock.

Both of these conditions are valid and are in the interests of the local amenity so cannot see what has changed in the locality to now have them removed.

NELC Planning Department sets Conditions to protect all parties and I am concerned that conditions placed on any planning application is of no consequence and can be disregarded

Comment: My family have been operating an intensive livestock unit at Hazeldene cooper lane for approximately 60 years and will continue to do so for many years to come. We have highlighted the issues of noise, smell, flies out of hour operations etc on more than several occasions. This was all investigated before the planning application was approved, one of the conditions the planning application was approved was condition 5 of the decision of notice, which was to basically create a 30-meter buffer zone from the northern boundary into the site where NO dwellings OR gardens shall be located. - Reason. In the interests of residential amenity in accordance with policy 2 of the north east Lincolnshire local plan 2013 - 2032. This is to protect the new residents as well as ourselves as a fully operational pig farm. In the odour report it shows that the sniff tests were taken place in the winter months, and none taken in the summer when the smells would be at its highest due to the annual spreading of pig muck onto the harvested land as done every year since the piggery has been in operation and will continue. The buffer zone will surely once set with trees will protect the new residents from some of the adverse effects of living in proximity of a fully operational pig farm and will protect the farm business from future complaints, of which we cannot be responsible, nor should our business be in any way prejudiced if the buffer zone is removed. I am the owner and occupier of Hazeldene, the intensive livestock unit (ILU) to the north of the proposed site.

On the occasion of all appeals, The Secretary of State concluded that the adverse physical factors associated with the nearby intensive livestock unit warranted the refusal of planning permission, however it was agreed that there should be a 30-metre buffer zone from the northern boundary into the development site.

We understand that North East Lincolnshire Council has made significant progress with its new Local Plan, which has been through consultation and independent examination. Whilst this process has resulted in the altering of various planning policies, the fact still remains that materially there has been no change to the intensive livestock unit at Hazeldene.

My business is still in full operation and has capacity for up to 400 head of pigs. The unavoidable physical effects that have been the consistent reason for refusal of previous applications and dismissal of previous appeals remain unaltered regardless of whether planning policies may be changing in the future. Our entirely legal and long-established operations simply cannot avoid the generation of noise, smell, flies, vehicle movements (livestock collection and delivery, as well as feed deliveries), manure handling, storage and disposal. These effects are potentially 24-hour

certainly, outside recognised working hours - when domestic property occupiers would be seeking not to be disturbed.

In order to avoid the needless 'chaos and confusion' originally identified by the first Appeal Inspector, I request that this application is refused without delay.

In the event that the Council see fit to grant permission despite the obvious future problems, then I must request that a Section 106 agreement be put in place between the Council and the applicant, whereby there is both: -

1. an obligation on the developer to notify prospective purchasers of any of the new dwellings of the existence of my ILU within 72 metres of their property: and

2. an unlimited indemnity from the applicant so I can pursue the Council for the financial impact of permitting the removal of the 30-metre buffer zone

This latest proposal which addresses the previous highway objection would appear to indicate that an informal agreement has been reached with the Council's Highways Engineer on necessary measures to be undertaken to overcome previous concerns, thereby enabling the proposal to go ahead.

However, no consideration whatsoever appears to have been given to the overriding issue of the suitability or otherwise of the proposal on the residential amenity of the area affected. This important planning aspect surely warrants at least the same degree of concern and consideration as the highway aspect, especially as what is being proposed involving as it does, the deliberate revving of motorcycle engines, is a normal part of this operation. If Planning values are in any way meaningful, therefore, and recognising that such a use would be totally incompatible with the ideals of a residential area and more appropriately located within an industrial setting, it is inconceivable that this should be allowed to take place.

I recognise that it could be argued that the noise and nuisance aspect which would inevitably occur could be controlled by imposing planning conditions to limit the activities, but surely this would be wholly impracticable as far as any meaningful enforcement is concerned when the work being carried out is reliant upon noise creation as an integral part of the business use which the applicant wishes to undertake.

Members of the Planning Committee will not need reminding that motorcycles are intrinsically noisy machines. To grant approval to such an activity in what is principally a residential part of the town would be wrong and show a complete disdain for the welfare of persons living nearby.

In view of this, I hope and trust that the Planning Committee or, if the application is to be determined by an Official, will not be swayed by the apparent support indicated by the applicant, and that the previous correct decision not to allow this intrusive use will be re-affirmed in accordance with the Council's own adopted policy, to which reference has been made in the Report to Committee in respect of application DM/0301/23/FUL and continues to be fully applicable at this time.

According to the definitions from the Environmental Protection Act 1990 (EPA 1990), the Pollution Prevention and Control Act 1999 (PPCA 1999), and the EU Directive on Industrial Emissions (2010/75/EU), radio-frequency radiation (RFR) emitted from masts and antennae can be shown to produce pollution or waste of a kind directly dangerous to human health. The laws specifically reference 'organ toxicity', listing as examples of this cell mutagenicity, carcinogenicity, and reproductive toxicity. A document produced by an EU entity (EUROPAEM 2016), has provided evidence that these are all (non-thermal) health effects of RFR. Thus, broadcast Wireless or Wi-Fi can be shown to create pollution/industrial waste, at the very least, to the standard that warrants investigation under the EPA 1990 and therefore that the erection of the proposed mast and its use are not sustainable given the nuisance control obligations that arise from the aforementioned legislation.

## 5.0 Public Health and Safety

The proposal is not sustainable in relation to the objective pursued through NPPF 2019, Section 8, paragraph 91, which states:

'Planning policies and decisions should aim to achieve healthy, inclusive and safe places which: c) enable and support healthy lifestyles, especially where this would address identified local health and well- being needs - for example through the provision of safe and accessible green infrastructure, sports facilities, local shops, access to healthier food, allotments and layouts that encourage walking and cycling.'

Neither ICNIRP nor any other official body has provided peer-reviewed evidence as to the cumulative effects of long-term exposure to radio-frequency radiation. Therefore, it is impossible to state at this time that any such mast as the one proposed can be deemed sustainable in respect of this NPPF objective.

Comment: This suggests that despite the UK government's guidelines to councils that they should accept the ICNIRP guidelines as guaranteeing the lack of negative health effects of radiofrequency radiation, the opposite is likely to be the case. In 2011 the International Agency for Research on Cancer (IARC)/World Health Organisa¬tion, classified RF radiation as a Group 2B carcinogen. Studies found a correlation between RF radiation from mobile phones and two kinds of brain tumour: glioma (a cancer) and acoustic

neuroma.

A summary of the IARC's conclusions was published in Lancet Oncology, 2011, 12, pp 624-26

6.0 Precautionary Principle

My understanding of this matter is that it is mandatory that the Council and the applicant consider the possible impact of mobile phone masts, most especially 5G, on members of the public. It is within your own powers as a council to make sure people are safe. Sustainability demands that precaution.

The Precautionary Principle should therefore apply. For instance, we know the roads are dangerous and the Council have put up adequate crossing places for children and pedestrians. Traffic presents visible harm but 5G monopoles and masts are potential invisible harm - anyone spending a long period of time in the vicinity of a mast that emits radiation all day and night in a

dome effect, no matter what the level, is simply not proven to be safe; it is not a natural environment for humans, especially for children and young people.

In respect of the current planning application it should be noted that besides the bus station so near the site, there is a residential building across the main road. This means they will be constantly exposed to the highest level of radiation from the mast as they are so near it, and especially at night, the time when the human body is regenerating and thus most needs protection from such effects. ICNIRP standards discuss short-term exposure to radiation. They make no mention of the effects of exposure 24/7 for long periods of time such as those living in close proximity to masts are forced to endure.

The Precautionary Principle is defined as follows:

"When human activities may lead to morally unacceptable harm that is scientifically plausible but uncertain, actions shall be taken to avoid or diminish that harm."

### **Closing statement**

Many communities are taking action throughout the country and several Councils have felt it prudent formally to affirm their compliance with the Precautionary Principle when facing choices and decisions on any intensification or 'densification' of public or environmental exposure to RFR. This puts matters on hold for up to two years so that more research can be carried out towards making a proper informed decision. Adverse non-thermal effects have been known since 1733, including EHS from 1746. It is extraordinary that, nearly 300 years later, a small clique of wireless advocates, including the ICNIRP, still denies the established mainstream scientific evidence of adverse non-thermal effects, such as EHS and cancers, and still invalidly claims only thermal effects. In promoting this fiction against the mainstream science, they have been allowed to destroy the lives and livelihoods of millions of people, a process perhaps unique in human history both in scale and in duration. In 1733 non-thermal adverse effects were shown from EMFs. In 1746 non-thermal EHS was shown from EMFs. In 1893 non-thermal adverse effects were shown from RFR. In 1930 the primary adverse effects of RFR in nervous tissue were shown as non-thermal. Internal heating was a secondary by-product of RFR. In 1932 cases of non-thermal EHS were described in Germany. In 1935 the USSR adopted non thermal guidelines. In 1945, radar at non-thermal levels was shown to cause cataracts and cancer. In 1957 parts of the US military rejected this non-thermal scientific evidence. They imposed Schwan's 1953 guidelines based on Schwan's heating myth, described by other parts of the military as 'arbitrary' and unscientific. In 2002 the ICNIRP recognised the need for non-thermal guidelines but in 2020 still proposed only thermal ones. In 2021 US Appeal Judges used the same word 'arbitrary' to describe the FCC's similar failure to assess the nonthermal effects, established since 1733.

# FURTHER PROGRESS ON NON-THERMAL ADVERSE EFFECTS

- In November 2021, the UK High Court in a landmark case overturned approval for a 5G mast since in part the council failed to address the non-thermal health impacts.

In February 2022, Prof. Hardell et al. published the first definitive health study on 5G. It showed non-thermal EHS symptoms in residents living below a 5G mast on a block of flats.
In April 2022 Pittsfield's Board of Health in the USA issued a cease and desist notice against a 5G mast after nearby residents developed EHS symptoms from its non-thermal radiation.

- In May 2022 Prof. Belpomme et al. published a study confirming non-thermal EHS: there are "sufficient data for EHS to be acknowledged as a distinctly well-defined and objectively characterized neurologic pathological disorder".

In May 2022, the Action Against 5G campaign under Michael Mansfield QC was allowed to resume its challenge over the government's failure to provide adequate information about 5G's non-thermal risks, under the Human Rights Act 1998 protecting life, health and dignity.
In May 2022, Dömötör Z et al confirmed non-thermal EHS in an ecological study.

- In June 2022, a French court ordered a non-thermal 4G mast to be switched off because of the deaths of 20% of a herd of cows after the mast was activated.

- In June 2022, a German court confirmed that landowners and telecoms are liable for nonthermal harm from masts.

# UNSCIENTIFIC DENIALS OF NON-THERMAL ADVERSE EFFECTS

In May 2022 an anonymous author denied that ICNIRP was unscientific without mentioning the adverse non-thermal effects, known since 1733, which ICNIRP unscientifically still denies.
In May 2022, in an attack on Prof. Frank's criticism of 5G and the need for protection against established non-thermal effects, an anonymous ICNIRP author claimed that "the lowest exposure levels that have been found to cause harm, cause that harm via heating" and thus "all adverse health effects are protected against" if ICNIRP continues to ignore established nonthermal effects.

- In June 2022, Nordhagen EK et al. showed that ICNIRP's circularity of authorship in trying to support its rejection of non-thermal effects appears very close to fraud.

- Throughout 2022, governments have recklessly deployed 5G radiation without scientific evidence proving its non-thermal safety, although the only live study on 5G's health impacts shows that 5G at non-thermal levels can cause EHS symptoms.

- In mid 2022, the UKHSA, which is "responsible for protecting every member of every community from the impact of ... radiological incidents and other health threats", has failed to protect the 3.6% of the population disabled by the extraordinary high levels of RFR/EMFs which the UKHSA allows in the UK by adopting the obsolete ICNIRP 2020 heating guidelines. These fail to protect against non-thermal effects such as ES and EHS.

- In 2022, by still refusing to accept non-thermal effects, UKHSA is failing "to make the nation's health secure", its primary aim. Instead, the UKHSA is victimising and harassing the 3.6% of the population whose health is ruined by the UKHSA's refusal to accept non-thermal effects

I am very concerned about the affect of the proposed development outlined in the above planning application and wish to object to planning permission being granted .

Whilst there are existing examples of side extensions with car ports in the Old Clee area, they are all very much shorter than the full length of the house usually with parking for only one car. This would be a very large scale development which would be running for the whole length of the house and with towering brickwork coming right up to the party wall. It is very domineering and oppressive. It will be very detrimental to the character and amenity of number 4. My property is built at an angle to number 6, so I will be looking at this brickwork both when I am in my kitchen and also when I am sitting in my back lounge. There will be significant loss of natural light to my property when the sunlight is coming from the direction of the Frobisher Avenue road in the daytime and more loss of natural light to the rear of my property when the sun moves around the back of number 6 in the evening. There will be overshadowing of a large part of my drive. My rear garden is very small and is the only area of number 4 where there is any privacy to be obtained when sitting outside. The new development will render it unusable for this purpose as it will take

on the feel of a sunless courtyard.

We reviewed the proposals for a new development to the rear of my property which identifies a large, gabled garage and playroom. The plans show a distance thought to be 400mm between the building and my garden fence. The rear of the proposed building has three windows at a height which will overlook the surrounding garden fences. No provision for drainage or other utilities is shown.

My wife and I have the following concerns:

1 there is insufficient distance around the proposed building to allow access or maintenance of either that building or the fences and walls which border the garden of no.1. Increase to 1m would substantially remedy this.

2 the height of the building would not allow access with a ladder at a safe 1 in 4 angle.

3 the considerable size of the building will deliver a substantial volume of drainage especially during heavy rainfall, while a significant amount of potential draining garden surface area will have been displaced by the building. The

area is already in an area of flood risk and without a proper scheme to provide adequate drainage we fear existing facilities will be overwhelmed.

4 the positioning of windows in the plans provides for gardens to the rear and side of it to be overlooked. A slightly lower position would prevent this and the inclusion of frosted glass or similar would also assist.

5 in general terms, this is a surprisingly large development, well beyond the re-provisioning of a garage and introduces a much higher density of building to this comparatively green area of the borough changing the nature of the area. I have heard mention that this would be a prelude to further application to extend into a second domestic residence on the plot of no.1 akin to similar expansion on the other side of Cumberland Avenue.

Many thanks for bringing the revised plans for the above to my attention.

The changes to location are welcome and although comparatively minor they will address some of our concerns. However, the issues of being overlooked from the proposed rear windows, the sheer size of the construction, even with reduced height, and the considerable issue of no professional solution to surface drainage, do not appear to have been addressed.

Since my original comments I have noticed that another property some ten doors away from this has obtained approval for a change of use to a "granny annexe". I suspect that a similar intent may lie behind this application, and as I mentioned before these changes will increase building density and reduce the green credentials of the area. A simple garage would not affect the area in the same way.

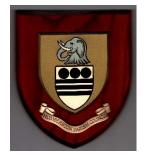

I write in relation to the above planning application. We live at 6 Park Avenue, and the end of our garden backs onto 1 Cumberland Avenue's garden. My first interpretation of the planning application was that it implied (erroneously) the existing garage was to be demolished and rebuilt with a games room added. Fortunately a neighbour brought the plans to my attention, illustrating that the floor area (over 4 times the original garage) was sufficient for a simple conversion to a second dwelling at a later date; and situated much further away from the house with the extended drive walled off from the garden, providing a separate access. No doubt another drive (and garage) would duly appear on the other side of the house for their use! I am also concerned with the position of the post box windows on the end elevation. Any one stood inside the proposed building with their back to the garage wall, would have line of sight into the back bedroom windows of Nos 2,4, and 6 Park Avenue. This would be impossible if the new 'garage' was built where the existing garage stands. I am also concerned that the resulting building work would require the removal of at least one of the three trees at the site of the extension, possibly two. Great care and some expense has been taken to build the boundary walls around the trees to insure their health and survival, by ourselves and the previous owners of 1 Cumberland Avenue. I note that we are on the edge of the Wellow preservation area with its TPO's and the aim of preserving the landscape character of the area. Certainly some (if not all) of the trees in Park Avenue have TPO's. I am surprised that EQUANS did not raise this when they drew up the plans, as they are partners in the council's tree strategy. My final concern is for our privacy at No.6. should the proposed dwelling be built where the plans indicate, especially if trees are removed or subsequently die.

I wish to make the following comments and requests for conditions to be placed on the planning application if it given approval by the council.

- Under the design and access statement it states, 'There are a number of trees and shrubs lining the ditch to eastern boundary, one of the ash trees will be removed, existing hedge will be reduced in site to around 2m,' I question why, if it is a healthy tree should it be cut down and also that the reduction of the hedge will still leave a barrier between the said development and the Carrington Gardens development, without having to erect further fencing.

- It also states 'The proposed surface water drainage will comply with the strategy agreed during the outline application. The surface water runoff from the proposed roofs will discharge into an onsite soakaway which has an overflow into a land drain that has been proposed to run along the eastern boundary which discharges to in the ditch at the southern end of the enlarged site.' This land drain or Swale as it is known is overgrown, and full of detritus both vegetation and builders rubbish-a requirement to have it cleaned/ dredged prior to any building work starting, if this is not done water will sit in the said drain becoming stagnant leading to smells in the summer and stimulation of unwanted insect life-mosquitoes.

- Unless there is a proper hedge screen between the proposed new build and the present properties on Carrington Gardens those properties will suffer from lack of privacy providing visual access into them in a way that was not possible before. Residents should not be expected to make arrangements to protect their own privacy in these situations.

- Conditions of approval of planning

Due to being close to an already developed residential development-Carrington Gardensconditions should be set regarding hours of work during the building process as in line with other residential developments.

8am-6pm Monday -Friday

8-1 pm Saturday

No work on Sundays or Bank Holiday

- Loss of trees and nature conservation --We have already seen a section of mature hedgerow ripped out to enable fencing to be erected for another property on the development losing valuable habitat and nesting for the local wildlife. I would hope the council does not let this happen on this or further proposed planning applications on the site. Mature hedgerows are protected by law during the main breeding season for nesting birds, which usually runs throughout March to August each year. It is an offence under Section 1 of the Wildlife and Countryside Act of 1981 to intentionally take, damage or destroy the nest of any wild bird while it is in use or being built, or to intentionally kill, injure or take chicks or adults, or intentionally take or destroy any eggs. As we are now coming to the beginning of March and construction of the building has already commenced I would hope no further work will be carried out to trees and hedgerows until at least September 2023 and then if at all.

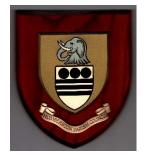
