This temporary prohibition is required because works are being or are proposed to be executed on or near the road by Kiely Bros. on behalf of North East Lincolnshire Council. These works are detailed as the 2023 NELC Surface Dressing Programme. Works will be phased in order to minimise disruption to traffic.

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation on **Tuesday**, **29 August 2023** and shall continue for a period of eighteen months unless extended by Order of the Secretary of State for Transport.

Exemptions to the order will be for authorised vehicles only, as listed below.

- Liveried Local Authority Vehicles (ENGIE/ NELC)
- Emergency Vehicles (Fire, Police, Ambulance, Coast Guard)
- Authorised Contractors
