**THE NORTH EAST LINCOLNSHIRE BOROUGH COUNCIL**  
**ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14(1)(a)**  
**WELLOWGATE LEVEL CROSSING – WELLOWGATE, GRIMSBY**  
**(TEMPORARY PROHIBITION OF TRAFFIC – TTRO 23-074) ORDER 2023**

**WHEREAS** the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 hereby make the following Order the effect of which will be that **no person shall cause or permit** any motor vehicle, pedestrian or pedal cycle from **PROCEEDING** along the below sections of highway:

- A section of WELLOWGATE – Part length, from a point 20 meters north-west of WELLOWGATE LEVEL CROSSING to a point 20 metres south of WELLOWGATE LEVEL CROSSING.

Alternative route 1: Wellowgate, Duchess Street, Garden Street, Abbey Walk, Osborne Street, South St Marys Gate, Bethlehem Street

Alternative route 2: Bethlehem Street, South St Marys Gate, Garden Street, Duchess Street, Wellowgate

This temporary prohibition is required because works are being or are proposed to be executed on or near the road by Network Rail These works are detailed as level maintenance works at WELLOWGATE LEVEL CROSSING.

Works will be undertaken overnight between 00.01hrs and 08:30hrs (daily) to minimise disruption to traffic.

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation on **Sunday, 08 October 2023** and shall continue for a period of eighteen months unless extended by Order of the Secretary of State for Transport.

There are no Exemptions to the Order on the grounds of safety.

The Order may be cited as "The North East Lincolnshire Borough Council, Road Traffic Regulation Act 1984 – Section 14(1)(a), Wellowgate Level Crossing- Wellowgate, Grimsby, (Temporary Prohibition Of Traffic – TTRO 23-074), Order 2023"
