COSGROVE STREET, CLEETHORPES
(TEMPORARY PROHIBITION OF TRAFFIC– TTRO 23-087) ORDER 2023

WHEREAS the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 hereby make the following Order the effect of which will be that **no person shall cause or permit** any motor vehicle, pedestrian or pedal cycle from **PROCEEDING** along on the below sections of highway:

- A section of COSGROVE STREET – From the property boundary of No.5 COSGROVE STREET heading in a south easterly direction to the property boundary of NO.35 COSGROVE STREET 80 metres

Alternative route: Market Street, Short Street, St Peters Avenue, De Lacy Lane.

This temporary prohibition is required because works are being or are proposed to be executed on or near the road by Utilities services LTD. These works are detailed as poling works on behalf of BT Open Reach.

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation on **Tuesday, 03 October 2023** and shall continue for a period of eighteen months unless extended by Order of the Secretary of State for Transport.

There are no exemptions to the order on the grounds of safety.

The Order may be cited as "The North East Lincolnshire Borough Council, Road Traffic Regulation Act 1984 – Section 14(1)(a), Cosgrove Street, Cleethorpes (Temporary Prohibition Of Traffic – TTRO 23-087), Order 2023"
