Introduction

The 2023 parent survey was undertaken in NEL from late August to the end of September. The survey went out via the social media platforms and was also shared by our childcare providers. A total of 498 surveys were started with 430 being completed or partly completed.

Summary

Most respondents had more than one child (63%) with 42% of all having 2 children. The most represented age group was the parents /carers of Primary aged children at 46%., followed by the under 2's (16%) and 3- and 4-year-olds (14%)

Less than half (42%) of families already use formal childcare. This is a decrease from last year of 13% however 24% of respondents left the question and didn't answer. For those who do not use formal childcare, not needing any was the main reason at 51%, followed by not being able to afford it at 32%.

Most families currently use childcare to enable them to work (84%) with the majority (62%) using childcare all year round.

Over half of those responding (64%), could get the right amount of childcare required to enable them to work. This figure dropped to 52% for those who needed a funded childcare place. The main reason for not being able to access the childcare families required was that they cannot afford the hours that they need. Needing atypical hours, before 8am (56%) and after 6pm (24%) were also stated as a barrier to accessing the required hours.

Since June 2022, 38% of families have used more childcare than the previous year. A third of families (34%) had little or no change to their childcare needs whereas 28% stated they now use less: 20% stated that they can no longer afford to pay the childcare costs.

1. Childcare Preferences

Most families prefer their childcare to be close to home (51%) and 64% need childcare in order work, study, or train. Sixty-five percent of respondents needed 15 or more hours per week.

2. General comments

There main themes from the comments included

- **2.1 Affordability** Many families found childcare to be expensive with some paying out a high percentage of what they earn for childcare. Most feel more is help is needed to support working parents, especially for those with under three years old. Some families stated that they rely on family and friends to help out as they cannot afford to use formal childcare for all the hours they need.
- **2.2** Availability- More families are finding the 8 to 6 childcare offers no longer meets their needs. This has increased by 7% since last year and is now 56% need an earlier start to meet their needs. Families with school age children would like more wraparound childcare to be available, ideally on or close to the school site.
- **2.3** Access- Some families have found it hard to find information about what is available locally. Others feel that there is not enough choice available especially for children with additional needs. The lack of funding to support children's needs outside of education is a barrier to the using childcare services.

3. What next

NELC will share the results of the survey with local childcare providers and will work with them to review and explore ways to increase their childcare offers to meet the needs of local families.




4. Results of the Parent Childcare Survey 2023

All fifteen wards within the borough were represented, including the full 0 to 18 age range within the responses. The biggest response (22%) came from families living in Sidney Sussex ward.

Over half (59%) of respondents had school age children with primary age also having the highest number 46%) across all age ranges. The under 4's represented 39% with 2% of respondents not specifying the age range of their children.

Q. Is there anything you would like to tell us about childcare provisions in North East Lincolnshire?

Affordability

- The after school club is over priced and therefore underutilised. At nearly nearly £25 for 3.30-6 it is unaffordable for most/ Inadequate provision at affordable rates (2)
- Not enough help or funding for low income/working families/ Too expensive, would cost more than I earn/ childcare is very expensive but have to pay or my full-time job. (5)
- The financial support for those that need childcare i.e. those working 30+ hours a week, who you claim earn too much to benefit, is embarrassing. Punishing the workers yet those out of work get it all free.
- Good ones never get in, super expensive if you don't get funded hours, my oldest is in nursery but struggling to go back to work as it would be £60 a day for my 8month old to go for a day
- I cannot increase my working hours because the increase in childcare costs would not make it viable (2)
- The cost needs to be brought down
- Not enough affordable childcare/after-school clubs. Wish my children's schools had decent breakfast clubs that I could use the gov scheme for
- I had no problem finding a nursery place from age one. My only issue is spending nearly £1000 a month on fees

Availability

- Only a certain few do the school pick ups from each school (2)
- My youngest isn't able to use his full 30 hours until June 2025 due to lack of spaces and I added him to the list before June this year. Yet my daughter has full flexibility due to spaces available.
- Nursery does not provide wrap around care, so have to split my childcare between two providers
- I am struggling finding the right childcare place for my baby daughter plus the cost of having her in nursery would mean all my extra wages would be going on childcare.

- Carers are few and far between and good quality carers for complex children with severe disabilities even harder to find
- Hardly any to choose from and very few provide 8-6 all year round which working people need
- Have to use a nursery out of town as no where local that I deem appropriate for my youngest
 has space. I also have a child in primary school and there is no after-school or holiday clubs
 available. The school provides a breakfast club which would meet working hours but only one
 days after school club, which ends at 4.15pm, and I wouldn't finish work until 5pm.at the
 earliest.
- The after school club availability for my 5 year old is completely insufficient in its entirety. After school clubs are only available for certain year groups on certain days and have limited capacity on a first come first served basis. This changes every half term which means some weeks/months my child cannot use the clubs even if they are available to her year group.
- Breakfast club starts at 8 and this is the time a lot of parents actually have to be at work
- There are fantastic provisions for childcare but do find with Holiday clubs the places are limited and not advertised as well as they could be
- My little boy is at preschool/nursery but they do not provide after school club for this age. I am a
 teacher so have to then get a childminder to pick him up. It's very upsetting not being able to
 pick my child up from school.
- I have been lucky with childcare for my children, the provider is open all year round extra BHs,
 weekend and christmas. The only problem was lack of flexibility, sessions had to be booked way
 in advance and had to be the same each week. I can appreciate why, but given some contracts
 and flexibility of employers now; it would be useful if childcare could be the same.
- Each school should offer breakfast club or afterschool club for all ages including pre-school /
 nursery. The providers should be funded appropriately in order to be able to provide high quality
 of care and service and keep their fees affordable. This will help families to work and earn good
 living, pay tax not use social care services to cover their needs. (9)
- There should be more activities for kids during half terms and school holidays and it should be
 more affordable for what they offer. There should be a kind of day camp for kids that provides
 not only activities but also food and means of transport. I am happy to pay for off school
 activities but £20 a day without food and transport seems a bit much and it is not even for a full
 working day.
- More flexible childcare required (3)
- There isn't sufficient places across settings in the area for the amount of children needing spaces
- School holiday and clubs hours are not great for working families most start at 9 and finish at 3 so still having to take holidays and cut hours to sort these things out
- Lack of places available in all areas. Long waiting lists. No primary's have wraparound. Expensive and only 1 choice in our area.

Access

I work as a part time carer I would love to complete my nursing but the placement hours are 7
am till 7 pm and would involve me traveling also I feel childcare limits me so much in my career
And is just enabling me to keep using universal credit If I was able to complete my nursing I
would be a sole provider and wouldn't need universal credit at all

- The wrap around with SEN support or for children with SEND/medical needs is poor. Smaller ratios and 1:1 is too difficult to access and the before, after school and holiday clubs are even harder to find (4)
- I believe all children should be entitled to a FULL TIME or equivalent (eg two part time) key worker. It's unfair that some children have a part time worker therefore their needs are only being met some of the time. How can they pick up on their targets and needs if they miss out on half of their education? I am otherwise happy with the childcare provisions provided
- The HAF vouchers can't be used because they don't need SEND needs
- Please ensure all your staff have autism training, it's so difficult to find support.

Other

- NELC proposal to close Reynolds daycare had a negative effect on my mental health
- The quality varies dramatically
- I recently had to change from my previous childminder due to her cutting her days down and not enough space to cover the 30 hours funding. Also when my daughter was under 2 limited baby room spaces and also spaces in my childcare.
- Please support Scartho Nursery School in being financially viable for the setting and local authority.
- St Joseph's Catholic Primary Voluntary Academy has been a big help with childcare provisions.
- The Children's House in Stallingborough is fab and fits our needs
- More SEND training given to child care providers please.
- My child care setting is amazing, it is important that my child go to setting in their local area so allow them to build friends ready for school.
- Trying to close Reynolds day care put a lot of pressure on families to look for other alternatives and there was not many options providing a full day care option.
- I wish the 15 hours funding was available for all working families like the 30 hours is.
- I feel deeply that the maintained council provision should be protected as they provide a quality of care and education that you can't find elsewhere. If it's Possible, offering places for 2year olds as the funding rolls out would be fantastic.
