## THE NORTH EAST LINCOLNSHIRE BOROUGH COUNCIL ROAD TRAFFIC REGULATION ACT 1984 (SPECIAL EVENTS) – SECTION 16A NEW YEARS DAY 2024 10KM RACE, CLEETHORPES (TEMPORARY PROHIBITION OF TRAFFIC – TTRO 23-007) ORDER 2023

<u>WHEREAS</u> the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Section 16 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 hereby make the following Order the effect of which will be that **no person shall cause or permit** any motor vehicle or pedal cycle, from **PROCEEDING** along the below sections of carriageway between 08:00hrs and 13:00hrs on **Monday 01**<sup>st</sup> **January 2024.** The extent of the closures will be:

KINGS ROAD (NORTHBOUND CARRIAGEWAY) – from its roundabout junction with NORTH SEA LANE / ST ANTHONYS BANK ROAD to its junction with CROMWELL ROAD.

CROMWELL ROAD (WESTBOUND CARRIAGEWAY) – from its roundabout junction with KINGSWAY / KINGS ROAD to its junction with HARDYS ROAD.

HARDYS ROAD (SOUTHBOUND CARRIAGEWAY) – from its junction with CROMWELL ROAD to its junction with CHICHESTER ROAD.

CHICHESTER ROAD (WESTBOUND CARRIAGEWAY) – from its junction with HARDYS ROAD to its junction with TAYLORS AVENUE.

CHICHESTER ROAD (EASTBOUND CARRIAGEWAY) – from its junction with HARDYS ROAD to its junction with KINGS ROAD.

A1098 TAYLORS AVENUE (SOUTHEASTBOUND CARRIAGEWAY) – from its junction with CHICHESTER ROAD to its roundabout junction with A1031 HUMBERSTON ROAD / A1098 HEWITTS AVENUE.

A1031 HUMBERSTON ROAD (SOUTHEASTBOUND CARRIAGEWAY) – from its roundabout junction with A1098 TAYLORS AVENUE / A1031 HUMBERSTON ROAD / A1098 HEWITTS AVENUE to its roundabout junction with A1031 CHURCH AVENUE / PARK LANE / NORTH SEA LANE.

NORTH SEA LANE (EASTBOUND CARRIAGEWAY) – from its roundabout junction with A1031 HUMBERSTON ROAD / A1031 CHURCH LANE to its roundabout junction with ANTHONYS BANK ROAD / KINGS ROAD.

Alternative route: KINGSWAY (SOUTHBOUND), KINGS ROAD (SOUTHBOUND) NORTH SEA LANE (WESTBOUND), A1031 HUMBERSTON ROAD (NORTHWESTBOUND), A1098 TAYLORS AVENUE (NORTHEASTBOUND)

Adjoining streets may be affected for a short period of time whilst the race passes but will be reopened as soon as it is safe to do so.

The above temporary prohibitions are required to safely set up and facilitate the New Years Day 2024 10km race being held by Cleethorpes Athletics Club.

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

EnGFReF: TTRO 23-007

The Order shall come into operation on **Monday, 01 January 2024** and shall continue for a period of three days unless extended by Order of the Secretary of State for Transport.

Exemptions to the order will be for authorised vehicles only, as listed below.

- Emergency Vehicles (Fire, Police, Ambulance, Coast Guard)
- Authorised Contractors

The Order may be cited as "The North East Lincolnshire Borough Council, Road Traffic Regulation Act 1984 (Special Events) – Section 16A, New Years Day 2024 10km Race, Cleethorpes (Temporary Prohibition of Traffic – TTRO 23-007), Order 2023"
