- 8. Introduce Prohibition of Waiting restrictions "Monday Friday, 8am 9.30am and 3pm 4pm" on a section of Broadway, Grimsby
- 9. Introduce Prohibition of Waiting restrictions "Monday Saturday, 8am to 6pm" on a section of Reynolds Street, Cleethorpes
