20th February 2025

The proceedings were opened with prayers by the Mayor's Chaplain.

NEL.71 MAYOR'S ANNOUNCEMENTS

The Mayor reminded Members of the forthcoming Mayor's quiz night and coffee morning, both in aid of the Mayoral charities. In addition, he hoped Members would join him for a 24-hour litter pick on 1st April 2025, also in support of the Mayoral charities.

NEL.72 APOLOGIES FOR ABSENCE

Apologies for absence from this meeting were received from Councillors Downes, Goodwin, Haggis and Jervis.

NEL.73 DECLARATIONS OF INTEREST

The Monitoring Officer provided general advice to Members on declaring interests with regard to the budget and setting of the Council Tax.

There were no declarations of interest in relation to any item on the agenda for this meeting.

NEL.74 BUDGET AND MEDIUM-TERM FINANCIAL PLAN 2025/26 – 2027/28

The Council considered a report from the Portfolio Holder for Finance, Resources and Assets presenting the Budget and Medium-Term Financial Plan 2025/26 – 2027/28.

The Leader of the Council, Councillor Jackson, made his budget statement and moved the recommendations as set out in the report together with an additional recommendation agreed at the meeting of Cabinet on 12th February 2024. This related to a recommendation from formal budget scrutiny requesting that a budget of £150k be apportioned for the next two years from the planned use of flexible capital receipts to the public health budget to support transformational projects, which was agreed by Cabinet subject to the realisation of appropriate capital receipts and appropriate projects being accompanied by suitable business cases.

The Leader noted that the proposed budget supported the strategic outcomes and priorities set out in the Council Plan, as agreed by Council at its meeting in December 2024. The focus was on making North East Lincolnshire a better place for our children and young people approach, delivering what was needed to attract new investment, jobs and wealth to the area. He set out the approach to be taken to funding key areas of the council's business and reported on the significant regeneration programme being delivered across the Borough. Investment in frontline services was being maintained. Reserves were also being bolstered in recognition of the economic challenges faced by the council. He noted that the council was one of few local authorities not levying the full 5% council tax increase. The Leader thanked the finance team for their work on the budget and he took the opportunity to thank officers for the work put in to delivering services across the council. He commended the budget to the council, noting that his administration was delivering its priorities whilst maintaining healthy and sustainable finances. Councillor Harness, Portfolio Holder for Finance, Resources and Assets, seconded the budget recommendations and summarised the key financial points in the report.

Councillor Wheatley, as Leader of the Labour Group, voiced her opposition to the budget proposals. She felt that the budget proposals did not address the areas that needed action, for example, taking young people out of poverty. She felt that the proposals lacked ambition and focus and failed to meet the expectations of residents.

Councillor Aisthorpe moved an amendment to the budget to pilot an Operation Clean and Green scheme for a period of one year funded by a £200k allocation from the 2025/25 Transformation Fund as follows:

4 Barrow Operatives (£35k each) - £140k 1 Urban Litter Ranger post - £38k Associated equipment - £22k Total cost - £200k

This would include the extension of enhanced cleaning to East Marsh, West Marsh, Park, Heneage, South and Sidney Sussex wards, the introduction of a community driven maintenance programme to enhance cleanliness, and the launch of a new group booking system for the 'Bulky Waste Collection' service. The Communities Scrutiny Panel would review the scheme's impact and cost effectiveness throughout the year. If the pilot proved successful, further consideration would be given to expanding the initiative, with future funding options explored to ensure its sustainability beyond the initial trial period.

This was seconded by Councillor Emmerson.

The Section 151 Officer provided advice to Council on the amendment.

Following a debate, the Mayor put the amendment to a recorded vote in accordance with the Constitution. The votes cast were recorded as follows:

- 2. That a 1.98% increase in Council Tax in 2025/26 be approved.
- 3. That the application of a 2% Adult Social Care precept in 2025/26 be approved.
- 4. That the business plans, as contained within Appendix 1 (Annex 1) of the report now submitted, be approved.
- 5. That the Capital Investment Strategy, as included within Appendix 1 (Annex 3) of the report now submitted, be approved.
- 6. That the 2025/26 2027/28 Capital Programme, as set out in Appendix 1 (Annex 2) of the report now submitted, be approved.
- 7. That the Flexible Use of Capital Receipts Policy, as included within Appendix 1 (Annex 7) of the report now submitted, be approved.
- 8. That, further to the recommendation from formal budget scrutiny, a budget of £150k be apportioned for the next two years from the planned use of flexible capital receipts to the public health budget to support transformational projects, subject to the realisation of appropriate capital receipts and appropriate projects being accompanied by suitable business cases and that the Section 151 Officer be authorised to make appropriate adjustments to the Budget and Medium Term Financial Plan.

9. That an Operation Clean and Green scheme be piloted for a period of one year funded by a £200k allocation from the 2025/25 Transformation Fund with the scheme's impact and cost effectiveness reviewed by the Communities Scrutiny Panel throughout the year.

NEL.75 SUSPENSION OF STANDING ORDERS

NEL.76 COUNCIL TAX 2025/26

- 2. That the Council Tax requirement for the Council's own purposes for 2025/26 (excluding Parish precepts) is £92,146,949.
- 3. That the following amounts be calculated for the year 2025/26 in accordance with Sections 31 to 36 of the Act:
 - (a) £387,163,152 being the aggregate of the amounts which the Council estimates for the items set out in Section 31A(2) of the Act taking into account all precepts issued to it by Parish Councils.

- (b) (£294,031,167) being the aggregate of the amounts which the Council estimates for the items set out in Section 31A(3) of the Act.
- (c) £93,131,985 being the amount by which the aggregate at 3(a) above exceeds the aggregate at 3(b) above, calculated by the Council in accordance with Section 31A(4) of the Act as its Council Tax requirement for the year. (Item R in the formula in Section 31B of the Act).
- (d) £1,972.91 being the amount at 3(c) above (Item R), all divided by Item T (1(a) above), calculated by the Council, in accordance with Section 31B of the Act, as the basic amount of its Council Tax for the year (including Parish precepts).
- (e) £1,035,545.99 being the aggregate amount of all special items (Parish precepts) referred to in Section 34(1) of the Act (as per the attached Appendix A) and Charter Trustees.
- (f) £1,950.97 being the amount at 3(d) above less the result given by dividing the amount at 3(e) above by Item T (1(a) above), calculated by the Council, in accordance with Section 34(2) of the Act, as the basic amount of its Council Tax for the year for dwellings in those parts of its area to which no Parish precept relates.
- (g) £1.53 Grimsby and Cleethorpes Special Expense area £50,509.84

being the amounts to be added to the amount at 3(f) above being the amounts of the special item or items relating to dwellings in those parts of the Councils area mentioned above divided in each case by the amount at 1(b) above, calculated by the Council, in accordance with section 34(3) of the Act, as the basic amounts of its Council tax for the year for dwellings in those parts of its area to which one or more special items relate.
