

Operational Officer Decision Record

1. Subject and details of the matter (to include reasons for the decision and detail of any previous cabinet decision)

On 5 April 2023 Cabinet approved to progress the opportunity to apply for grant funding to the Football Foundation to secure investment to develop small-sided sports and recreational activity PlayZones in North East Lincolnshire, using up to £94,000 of Council investment as match funding in the worst case scenario to support the grant application.

Cabinet approved:

- 1. That the submission of a grant funding application to the Football Foundation to develop PlayZone sites in North East Lincolnshire, with an indication of a commitment of up to £94,000 of Council investment as match funding in the worst case scenario, to underwrite commitments from proposed operators, for the bid application in the event of failure and subject to a successful grant application be approved:
- 2. That the Director of Economy, Environment and Infrastructure, in consultation with the Portfolio Holder for Culture, Heritage and the Visitor Economy be delegated authority to commence a procurement exercise to engage a contractor to deliver the PlayZone sites and thereafter award, mobilise and implement such proposal with further authority to take all reasonable ancillary actions to ensure implementation.

- 3. That the Director of Economy, Environment and Infrastructure, in consultation with the Portfolio Holder for Culture, Heritage and the Visitor Economy be delegated authority to procure and thereafter award to and appoint operators to carry out the day-to-day management of PlayZone sites with further authority to take all reasonable ancillary actions to ensure implementation.
- 4. That the Assistant Director Law and Governance (Monitoring Officer) be authorised to execute and complete all requisite legal documentation in relation to the matters outlined above.

A previous Officer Decision Record on 2nd November 2023 (see Section 5 – Background Documents Considered) approved the following:

- Accepting the grant offer of £157,486 secured from the Football Foundation for a PlayZone pitch development at Grant Thorold Park.
- Contributing £51,302 match funding to the project, of which £40,000 is from Safer Streets Fund and the remaining £11,302 from PlayZone capital budget.
- Utilising the Football Foundation Delivery Process Model via Labosport to carry out the design and procurement of the PlayZone development. The use of the Football Foundation Model has maximised the project's chance of securing grant funding.

2. Decision being taken

That the Director of Economy, Environment and Infrastructure, in consultation with the Portfolio Holder for Culture, Heritage and the Visitor Economy award the contract for Grant Thorold PlayZone construction to Cleveland Land Services at £189,682.34.

In line with the Cabinet report to maximise the project's chance of securing grant funding the Council utilised the Football Foundation's framework to carry out the procurement for the main contractor Cleveland Land Services (CLS).

3. Anticipated outcome(s)/benefits

Begin the delivery of a refurbished small-sided playing pitch at Grant Thorold Park into a PlayZone facility with a tarmacadam surface, with primary focus on football and basketball. The development of this facility will support in the delivery of the Council's Sport & Physical Activity Strategy.

4. Details of any alternative options considered and rejected by the officer when making the decision

The Council have considered the alternative to do nothing. The current small-sided court at Grant Thorold Park is in a poor condition and based on existing budget, without external grant funding, current conditions are likely to remain or deteriorate further.

The Football Foundation funding conditions will need to be satisfied as part of the ongoing project delivery and future operation of the site. The risk of grant clawback is considered low.

The grant investment will place an obligation on the Council to provide annual revenue funding of up to £5,000 to cover PlayZone running costs for a 10-year period. The development of a partnership agreement with an operator for the PlayZone at Grant Thorold Park will aim to mitigate part of this annual cost.
