ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14(1)(a)
ABBEY DRIVE WEST & BARGATE AVENUE, GRIMSBY
(TEMPORARY PROHIBITION OF TRAFFIC – TTRO 24-048) ORDER 2024

WHEREAS the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 hereby make the following Order the effect of which will be that **no person shall cause or permit** any motor vehicle from **PROCEEDING** along on the below sections of highway:

- A section of ABBEY DRIVE WEST – from the northern boundary of 22 ABBEY DRIVE WEST heading in a north easterly direction to the junction of ABBOTSWAY, for a distance of 40 metres

Alternative route: Abbey Park Road, Abbey Road, Abbey Drive West (reverse route applies)

- A section of BARGATE AVENUE – from the junction of A1243 BARGATE heading in a easterly direction to the southern boundary of 59 BARGATE AVENUE, for a distance of 20 metres

Alternative route: A1243 Bargate, B1212 Welholme Road, Welholme Avenue, (reverse route applies)

This temporary prohibition is required because works are being or are proposed to be executed on or near the road by Network Plus. These works are detailed as gas mains replacement.

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation on **Monday, 24 June 2024** and shall continue for a period of eighteen months unless extended by Order of the Secretary of State for Transport.

Exemptions to the order will be for authorised vehicles only, as listed below.

- Livered Local Authority Vehicles (EQUANS / NELC)
- Emergency Vehicles (Fire, Police, Ambulance, Coast Guard)
- Authorised Contractors / Utilities / Waste

The Order may be cited as "The North East Lincolnshire Borough Council, Road Traffic Regulation Act 1984 – Section 14(1)(a), Abbey Drive West & Bargate Avenue, Grimsby, (Temporary Prohibition Of Traffic – TTRO 24-048), Order 2024"
