ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14(1)(a)

<u>CHICHESTER ROAD, CLEETHORPES</u> (TEMPORARY PROHIBITION OF TRAFFIC – TTRO 24-021) ORDER 2024

<u>WHEREAS</u> the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 hereby make the following Order the effect of which will be that **no person shall cause or permit** any motor vehicle, pedestrian or pedal cycle from **PROCEEDING** along on the below sections of highways:

- CHICHESTER ROAD part length from the junction of A1098 TAYLORS AVENUE heading in a south easterly direction to the junction of HARDYS ROAD.
 Alternative route: Hardy's Road, A1098 Taylors Avenue (reverse route applies)
- ALDRICH ROAD part length from the junction of CHICHESTER ROAD heading in a north easterly direction to the south western boundary of 54 ALDRICH ROAD, for a distance of 30 metres.
- LYNTON RISE part length from the junction of A1098 TAYLORS AVENUE heading in a north westerly direction, for a distance of 20 metres.
- A1098 TAYLORS AVENUE- Part length from the junction roundabout of HEWITTS CIRCUS heading in a north easterly direction to the junction of CHICHESTER ROAD.
 Alternative route: Trinity Road, Clee Road, A1031 Humberston Road(Reverse route applies)

This temporary prohibition is required because works are being or are proposed to be executed on or near the road by NELC. These works are detailed as NELC Highways carriageway resurfacing works.

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation on **Monday**, **29 July 2024** and shall continue for a period of eighteen months unless extended by Order of the Secretary of State for Transport.

Exemptions to the order will be for authorised vehicles only, as listed below. •

- Liveried Local Authority Vehicles (EQUANS / NELC)
- Emergency Vehicles (Fire, Police, Ambulance, Coast Guard)
- Authorised Contractors / Utilities / Waste

The Order may be cited as "The North East Lincolnshire Borough Council, Road Traffic Regulation Act 1984 – Section 14(1)(a), Chichester Road, Cleethorpes (Temporary Prohibition Of Traffic – TTRO 24-021), Order 2024"
