<u>WHEREAS</u> the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 hereby make the following Order the effect of which will be:

STANLEY STREET – Part length from the junction of HAMILTON STREET heading in a north easterly direction to the junction of A180 CLEETHORPE ROAD.

GRAFTON STREET – Part length from the junction of STANLEY STREET heading in a north westerly direction to the junction of HILDA STREET.

COPE STREET - Part length from the junction of GUILDFORD STREET heading in a south westerly direction to the junction of WEELSBY STREET.

MANSEL STREET – Part length from the junction of GRAFTON STREET Heading in a north easterly direction to the junction of HAMILTON STREET.

RIALTO AVENUE - Part length from the junction of B1213 HAINTON AVENUE for the FULL EXTENT.

PATRICK STREET – Part length from the junction of LEGSBY AVENUE heading in a north easterly direction to the junction of HIGHFIELD AVENUE.

SOUTHWOLD CRESCENT - FULL EXTENT

The above temporary prohibitions are required because works are being or are proposed to be executed on or near the road by North East Lincolnshire Council. These works are detailed as the highway maintenance scheme, surface dressing programme.

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation on **Wednesday**, **28 August 2024** and shall continue for a period of eighteen months unless extended by Order of the Secretary of State for Transport.

Exemptions to the order will be for authorised vehicles only, as listed below.

- Liveried Local Authority Vehicles (EQUANS / NELC)
- Emergency Vehicles (Fire, Police, Ambulance, Coast Guard)
- Authorised Contractors
