## **Holiday Activities and Food Programme**

Since 2021 North East Lincolnshire Council have provided free holiday activities to pupils aged 5 -16 year olds through the government funded HAF Programme.

The programme provides a healthy meal with enriching activities during the Easter, Summer and Christmas school holidays to all children eligible for a benefit related free school meals.

It has been widely documented that school holidays can be pressure points for some families due to increased costs during the school holiday times.

Some children are more likely to experience 'unhealthy holidays' in terms of nutrition and health.

Some children form lower income families are less likely to attend holiday activities.

This annual report aims to showcase the fantastic opportunities that our young people in North East Lincolnshire have been part of, working closely with providers to offer a broad range of holiday activities across the borough.

### **HAF in North East Lincolnshire**

The success of the programme continues to grow and evolve.

As the number of free school meals continues to rise locally the funding is vital to our families, it brings young people together, promotes healthy eating, safety, social inclusion and connects families with schools and their local communities.

Nearly 8000 children were receiving benefit related free school meals from March 2023 – April 2024.

In addition we supported families to children across the Local authority to children with an EHCP, Looked after or have a social worker.

We work with all schools in North East Lincolnshire to identify eligibility and assign holiday vouchers.

## **Evouchers – Holiday Activities booking system**

HolidayActivities is a platform designed and built specifically to support effective HAF programmes, enabling local authorities, activity providers and recipients easily and securely engage in HAF activities.

From Easter 2023 we procured an online booking system for parents/carers to receive their HAF vouchers and book activities.

Providers upload their offer – this is promoted through their social media platforms, in schools and on their websites

The Evouchers system connects to all schools management information system which allows eligible families to automatically receive a voucher code. Once the code has been activated by the parents/carers they are able to search and book on to a wider range of activities.

The system is a central platform for parent/cares, providers and the Local authority. Providers manage their own activities enabling them to take control; managing spaces, create registers and operate a waiting list.

**Easter** - This was the first time we used our central booking system for providers and parents.

Activities included Premier Education, Grimsby Town Football Club, Fierce Elite Cheerleading, Cottagers Plot Equestrian Centre, Lincs Inspire, Climb 4, Elsham activity centre, Wild pines outdoor adventures. Ice skating and indoor climbing wall.

**Summer** – Many activities were planned for the summer programme which included Outdoor activity Centre 3 day residential visit Kingswood Paddle boarding Rock Climbing Ice skating Bowling Farm visits, Visit to the local beach (Cleethorpes)to name a few!!!

**Christmas** is always a magical time of year for our families when they get to celebrate the end of the year with a traditional pantomime offer – Each child went to see a live pantomime performance with one adult member of their family, they received a snack bag, a light up fairy wand or sword for the show and a half time ice cream treat and selection box.

Over 60 children had the opportunity to watch a professional football match and have a matchday experience with Grimsby Town Football Club.

There were also a range of sports activities and arts and craft workshops.





## **Funding 2023 - 2024**

North East Lincolnshire council were allocated £794540 from the Department of Education to deliver the HAF Programme during the Easter Summer and Christmas holidays.

The funding had to cover a minimum of 4 days at Easter and Christmas and 16 days during the summer holiday period.

The funds were allocated to deliver face to face activities from the selected providers, capital expenditure for small equipment, booking systems and admin management for the Local Authority to deliver the full programme



# **Key findings / Challenges**

The booking system has enabled the Local Authority to receive and record more accurate data.

The reach lowered due to being able to identify unique numbers.

Bookings quickly increased after the Easter holidays once parents became more familiar with the booking system.

Non attendance has improved gradually.
