(Louth Road & Station Road,
New Waltham & Waltham)
(No. 10-01) Order 2010**

The Council of the Borough of North East Lincolnshire, hereinafter referred to as "the Council", in exercise of powers conferred on the Council under Sections 84(1) and (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order

1 Title

1.1 This Order shall come into operation on the *1st* day of *May* 2011 and may be cited as The Borough of North East Lincolnshire (Speed Limits) (Louth Road & Station Road, New Waltham & Waltham) (No. 10-01) Order 2010.

1.2 The Orders specified in Column 1 of Schedule 1 to this Order are hereby revoked to the extent shown in Column 2 of the said Schedule.

2 Speed Limits

2.1 **40 mph Speed Limit**

No person shall cause or permit any vehicle to be driven at a speed exceeding 40 miles per hour on the lengths of roads specified in Schedule 2 to this Order

2.2 **De-Restricted Road Speed Limit**

The lengths of road specified in Schedule 3 to this Order shall cease to be restricted roads for the purposes of Section 81 of the Act of 1984

EXTENT OF REVOCATION

all that part of the Schedule "40mph Speed Limit" that relates to the length of **Louth Road** extending from a point 70 metres north-west of the north-western kerbline of the B1219 Station Road, New Waltham to a point 207 metres north-west of the north-western kerbline of the B1219 Station Road, New Waltham;

a) all those parts of Schedule 4 "40mph Speed Limit" that relates to roads within the Parish of **New Waltham**

b) all those parts of Schedule 5 "De-Restricted Road Speed Limit" that relates to roads within the Parish of **Waltham**

Roads within the Parish of Waltham	
97WA82010 Station Road (B1219)	from a point 205 metres east of the eastern kerbline of Grimsby Road, B1203 to a point 416 metres south-west of the south-western kerbline of Louth Road, A16

Roads within the Parish of New Waltham	
99NW52010 Louth Road (A16)	from a point 505 metres south-east of the south-eastern kerbline of Maple Grove to the North East Lincolnshire Borough / Lincolnshire County Boundary (a distance of some 275 metres)

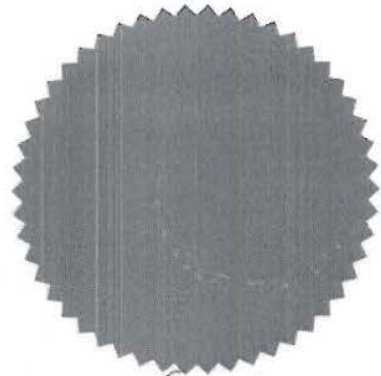
