**ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14(1)(a)**  
**HARRINGTON STREET, CLEETHORPES**  
**(TEMPORARY PROHIBITION OF TRAFFIC – TTRO (24-134) ORDER 2024**

**WHEREAS** the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 hereby make the following Order the effect of which will be that **no person shall cause or permit** any motor vehicle, pedestrian or cycle from **PROCEEDING** along the below sections of highways during the dates and times detailed below:

**04<sup>th</sup> November 24**

MANCHESTER STREET – Part length from the junction of OLIVER STREET heading in a north easterly direction to the intersection of HARRINGTON STREET, for a distance of 40 metres

HARRINGTON STREET – Part length from the intersection of MANCHESTER STREET heading in a north westerly direction to the junction of FULLER STREET, for a distance of 70 metres.

Alternative route: Fuller Street, A180 Grimsby Road, Manchester Street (reverse route applies)

**05<sup>th</sup> November 24**

HARRINGTON STREET – Part length from the junction of FULLER STREET heading in a north westerly direction to the junction of NEVILLE STREET, for a distance of 65 metres.

Alternative route: Neville Street, A180 Grimsby Road, Fuller Street (reverse route applies)

**06<sup>th</sup> November to 08<sup>th</sup> November 24**

HARRINGTON STREET – Part length from the junction of NEVILLE STREET heading in a north westerly direction to the junction of BLUNDELL AVENUE, for a distance of 210 metres.

Alternative route: Tiverton Street, A180 Grimsby Road, Fuller Street (reverse route applies)

The above temporary prohibitions are required because works are being or are proposed to be executed on or near the road by Advanced Utility Solutions. These works are detailed as These works are detailed as excavation works in the footway.

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation on **Monday, 04 November 2024** and shall continue for a period of eighteen months unless extended by Order of the Secretary of State for Transport.

Exemptions to the order will be for authorised vehicles only, as listed below.

- Livered Local Authority Vehicles (EQUANS / NELC)
- Emergency Vehicles (Fire, Police, Ambulance, Coast Guard)
- Authorised Contractors

The Order may be cited as "The North East Lincolnshire Borough Council, Road Traffic Regulation Act 1984 – Section 14(1)(a), Harrington Street, Cleethorpes, (Temporary Prohibition Of Traffic- TTRO 24-134), Order 2024
