TEMPORARY FOOTPATH CLOSURE OF
PUBLIC FOOTPATH 5, GRIMSBY AND WALTHAM PUBLIC FOOTPAHT 70
(NOTICE OF TEMPORARY FOOTPATH CLOSURE) ORDER 2024

WHEREAS the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), the Highway Authority for the above-mentioned path in the Borough of North East Lincolnshire, is satisfied that access should be prohibited on the said path by reason to avoid danger to persons using the path due to works taking place along it.

NOW THEREFORE the Council in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all powers them enabling in that behalf hereby make the following Order:-

1. No person shall proceed along the Public Rights of Way except for the developers, authorised contractors, emergency services (Fire, Police, Ambulance, Coast Guard) and Council officials.
2. The Public Rights of Way details which will be temporary closed are as follows:
 - Public Footpath 5, Grimsby between the highway known as Rivan Grove, Grimsby, Ordnance Survey Grid Reference TA526218, 405042 and Public Footpath 70, Waltham at Ordnance Survey Grid Reference TA526196, 404992.
 - Public Footpath 70, Waltham between Public Footpath 5, Grimsby Ordnance Survey Grid Reference TA526196, 404992 and the highway known as Fairway, Waltham at Ordnance Survey Grid Reference TA526116, 404380.
3. The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.
4. The Order will come into operation on the 1st July 2024 and shall continue in force for a period of six months then the Order ceases to operate unless extended by Order of the Secretary of State for Transport.
5. The Order may be cited as "The North East Lincolnshire Borough Council Temporary Path Closure of Public Footpath 5, Grimsby and Public Footpath 70, Waltham Order 2024".

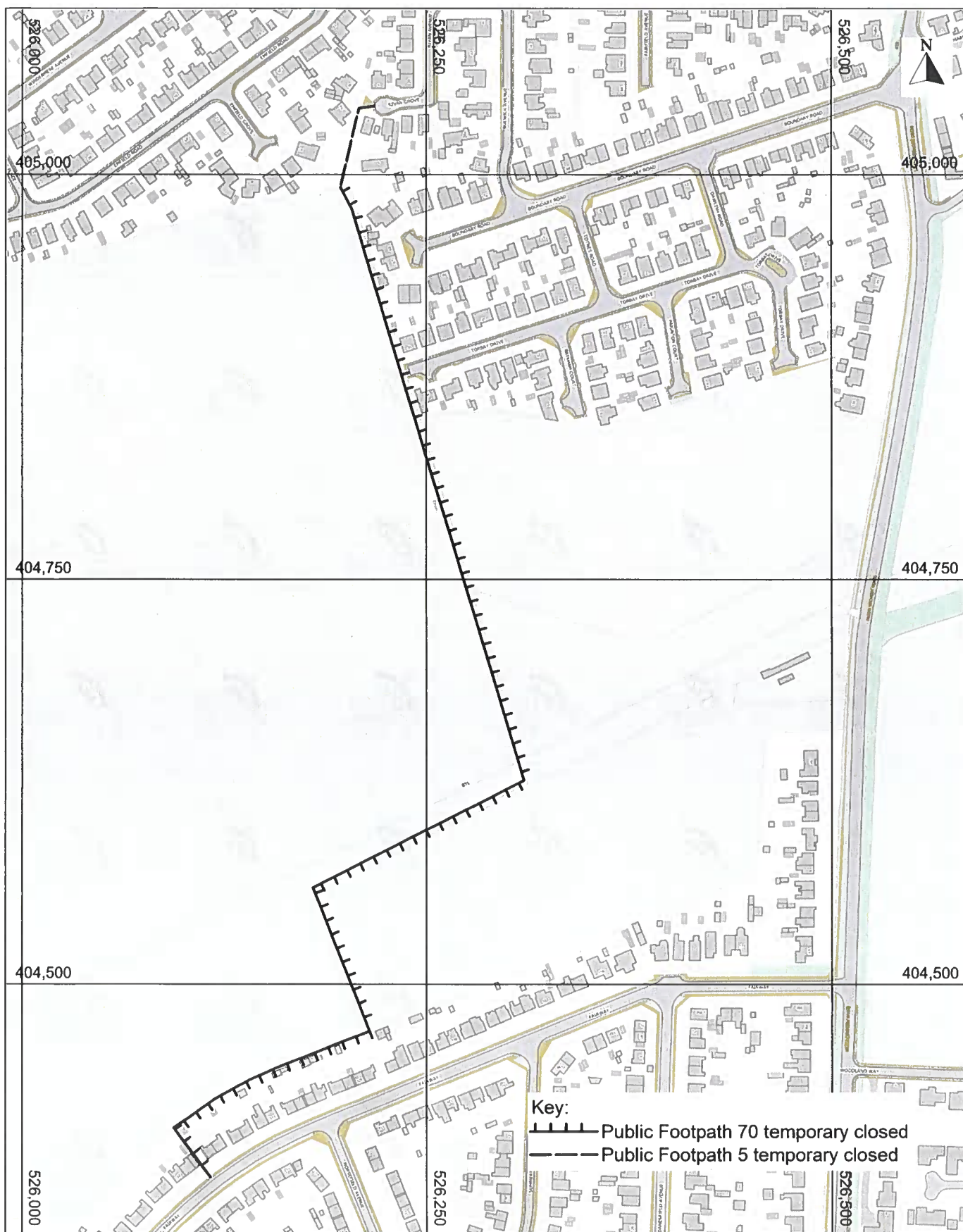
