The prevention of crime and disorder: As this business does not tell the truth of its ongoing on a Friday & Saturday night the right measures are not taken to protect the residents surrounding this venue. My house which is a housing association house given to us because of not 1 but 2 disabled children live within 15ft of loud thumping music going on way past the times stated straight into 2 bedrooms they are in and spend majority of there time in (my son actually passed out it was so loud). When these club nights are held it is always the under 30's the owner is attracting and what comes with that is lots of crime and disorder as they all leave & it can go on for as long as they like because no one moves them on, glasses being smashed over my wall drugs being taken in my gate area ? With a doorbell camera clearly recording them. Then the fallouts get well out of hand so very upsetting for my children who I've moved round the front because of the loud music but then we have them leaving round the front of house

Public safety: When he is having a clubbing night with dj's and loud loud banging constant booming music non of us feel safe going to are cars if I've left something in the car and that's started it's tuff I will have to wait until the morning as a women on my own with 3 children. If I feel like nipping to my mums in [redacted] on a weekend I need to make sure I am back early before the clubbing starts so the kids don't have to walk through all the gross behaviour and drug taken outside our house (no hiding it either little white bags up there nose) I have plenty of footage also following them to FOLK.

Prevention of public nuisance: I have just bought 3 cameras for outside my house for my safety and the children's only because of his club nights and nothing else no other reason but his club nights.. and if this place is aloud to go ahead I will get all the proof I need to take this much further with my housing team the press and I will go all the way to protect my children's health / mental health / safety in their own home.

The protection of children from harm: Think I have covered this ? My children are definitely in harms way on his clubbing nights every Friday and Saturday night.

If possible please suggest alterations to the application that would resolve the

problem mentioned above, again paying attention to the licensing objectives: No live music no clubbing nights including djs etc this business advertised on a live platform of a night with quite music older generation being all calm and mature? I've never ever seen that kind of cliental in FOLK on a Friday or Saturday night it's all a charade to cover up his money maker. If this business ran as what it says it is then absolutely would not be a problem to us would it ? Please think about that clearly especially with how many other food premises are around us Non of us make a complaint about any other business. What does Knoll street and Cambridge street have to do to prove to you the council what is actually going on here ? .
