North East Lincolnshire Bus Service Improvement Plan (BSIP) Cabinet Report – 20 October 2021

On 20 October 2021, Cabinet approved the North East Lincolnshire BSIP, which set out the Council's plans and ambitions for BSIP funding, and enabled the Local Transport Authority and bus operator, Stagecoach East Midlands, to opt into an Enhanced Partnership. Cabinet approved the following;

- 1. Approves the Bus Service Improvement Plan for submission to the Department for Transport (DfT) by 29 October 2021.
- 2. Delegates authority to the Executive Director, Environment, Economy & Resources, in consultation with the Portfolio Holder for Environment and

Transport, to:

- a. Deliver the Bus Service Improvement Plan from 1 April 2022. Should DfT award the Council a reduced funding allocation, the Executive Director, Environment, Economy & Resources, in consultation with the Portfolio Holder for Environment and Transport be authorised to approve a re-prioritised Bus Service Improvement Plan.
- b. Procure measures identified in the Bus Service Improvement Plan or reprioritised Bus Service Improvement Plan.
- c. Award contract(s) for the measures within the allocated budget to the project and to carry out all activity to mobilise and fully implement.

3. Authorises the Assistant Director Law, Governance and Assets (Monitoring Officer) to execute all documents in connection with the above.

BSIP Bus Shelter Project

Following the successful submission of the BSIP, North East Lincolnshire Council were awarded £4.7m over three years to support local buses. The Council were required to submit a programme to the Department for Transport (DfT) which identified the schemes, estimated costs (to the value of £4.7m) and estimated delivery dates. Within the BSIP programme a capital budget of £105,000 is available for bus shelter schemes which aim to improve the bus passenger waiting environment. Also, within the Local Transport Plan Capital Programme there is a contribution of £32,000 available to assist in the delivery of this project.

A compliant procurement exercise for 7 bus shelters has been completed. The following information provides a summary of the tender evaluation:

Reason for the Decision: The Council is required to demonstrate value for money in the procurement of 7 bus shelters under the Public Contracts Regulations 2015.

Process: This procurement exercise was conducted under Open procedure. Subject to the Public Contracts Regulations, Regulation 26(3)(a).

Length of Contract: The contract is for the supply and installation of 7 bus shelters in North East Lincolnshire.

Date of publication: 29/10/2024.

Responses received: Two compliant tender responses were submitted to the Council.

Assessment method/basis of award:

*Price = 60%

*Quality = 40%

Next steps:

Following the signature of this report, the pre-standstill notification letters will be issued to all tenderers. This starts the mandatory 10 day standstill period and confirms the identity of the preferred tenderer and the relative advantages of the bid which justified the award.

Post standstill letters will be issued once the stand still period has expired and providing any scrutiny period has passed successfully and the standstill period passed with no sustained challenges being received. The contract documentation will then be released at this point.

2. Decision being taken

The Director of Economy, Environment and Infrastructure in consultation with the Portfolio Holder for Housing, Infrastructure and Transport to award the contract to supply and install 7 bus shelters to Macemain + Amstad which is the Most Economically Advantageous tender submission.

3. Anticipated outcome(s)/benefits

The tender award will deliver 7 high quality stainless steel anti vandal bus shelters in the following locations:

- * Pelham Road outside the Academy, Immingham
- * Pelham Road outside Kennedy Way Shopping Centre, Immingham
- * Kingsway- opposite Kingsway Kiosks, Cleethorpes
- * Kingsway adjacent to Queens Parade, Cleethorpes
- * Kingsway opposite Brighton Street
- * Wingate Road Opposite Hilary Way, Grimsby
- * Louth Road adjacent to Toll Bar School, Grimsby

The delivery of this project will support in the delivery of the Council's BSIP.

4. Details of any alternative options considered and rejected by the officer when making the decision

Option 1 – Do nothing and return £105,000 capital funding to DfT. This option is not recommended as it may conflict with the Governments National Bus Strategy and this option may negatively impact any future DfT funding decisions.

Option 2 - Award the tender for the supply and installation of 7 bus shelters. This is the recommended option as the National Bus Strategy requires local authorities to provide high-quality public transport infrastructure in order to improve the journey experience for bus passengers.
