## THE NORTH EAST LINCOLNSHIRE BOROUGH COUNCIL ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14(1)(a) VARIOUS LOCATIONS – NELC PRE PATCHING PROGRAMME (TEMPORARY PROHIBITION OF TRAFFIC – TTRO (25-050) ORDER 2025

<u>WHEREAS</u> the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 hereby make the following Order the effect of which will be that **no person shall cause or permit** any motor vehicle, cycle or pedestrian from **PROCEEDING** along the below sections of highways during the dates and times detailed below:

 DAVID STREET – Part length from the junction of HENEAGE ROAD heading in a north easterly direction, for a distance of 180 metres.

Alternative route: N/A

The dates for these works will take place on 7<sup>th</sup> April 25 to 8<sup>th</sup> April 25.

• OXFORD STREET – Part length from the roundabout junction of PARK STREET heading in a north westerly direction to the junction of VICTOR STREET.

Alternative route: Victor Street, A180 Cleethorpe Road, Park Street (reverse route applies) The dates for these works will take place on 9<sup>th</sup> April 25 to 10<sup>th</sup> April 25.

• FORDS AVENUE – Part length from the junction of NICHOLSON ROAD heading in a south westerly direction, for a distance of 120 metres.

Alternative route: Fords Avenue, Oak Road, The Avenue, Radcliffe Road (reverse route applies) The dates for these works will take place on 11<sup>th</sup> April 25.

• ESTATE ROAD ONE – Part length from the junction of WOAD LANE heading in a south easterly direction to the junction of ESTATE ROAD THREE.

Alternative route: Estate Road One, Gilbey Road, Moody Lane, Woad Lane (reverse route applies) The dates for these works will take place on 15<sup>th</sup> April 25.

• ESTATE ROAD TWO – Part length from the junction of ESTATE ROAD FIVE heading in a south westerly direction to the junction of ESTATE ROAD SIX.

Alternative route: Estate Road Five, Estate Road Six (reverse route applies)

The dates for these works will take place on 16<sup>th</sup> April 25.

• TETNEY ROAD – Part length from the junction of B1219 HUMBERSTON AVENUE heading in a southerly direction to the junction of SOUTH SEA LANE, for a distance of 480 metres.

Alternative route: Humberston Road, Thoresby Road, Station Road, High Street, A16 Louth Road, B1219 Humberston Avenue

The dates for these works will take place on 16<sup>th</sup> April 25 to 17<sup>th</sup>April 25.

• ESTATE ROAD FIVE – FULL EXTENT

Alternative route: Estate Road Two, Estate Road One, Woad Lane.

The dates for these works will take place on 17<sup>th</sup> April 25.

 GILBEY ROAD – Part length from the junction roundabout of PYEWIPE ROUNDABOUT heading in a north easterly direction to the private access of THE DRAWING COURT INDUSTRIAL ESTATE, for a distance of 200 metres.

Alternative route: Gilbey Road, Moody Lane, Woad Lane, Estate Road One (reverse route applies) The dates for these works will take place on 18<sup>th</sup> April 25.

• WOAD LANE – Part length from the junction of ESTATE ROAD FIVE heading in a north easterly direction to the junction of ESTATE ROAD ONE.

Alternative route: Estate Road Five, Estate Road Two, Estate Road One (reverse route applies)

The dates for these works will take place on 22nd April 25.

 ALGERNON STREET - Part length from the junction of HENEAGE ROAD heading in a north easterly direction, for a distance of 110 metres.

Alternative route: N/A

## The dates for these works will take place on 23rd April 25 to 24<sup>th</sup> April 25.

• TORRINGTON STREET - Part length from the junction of HENEAGE ROAD heading in a north easterly direction, for a distance of 235 metres.

Alternative route: N/A

## The dates for these works will take place on 24<sup>th</sup> April 25 to 25<sup>th</sup> April 25.

• HENEAGE ROAD – Part length from the junction of WELHOLME ROAD heading in a south easterly direction to the junction of A46 WEELSBY ROAD.

Alternative route: N/A

## The dates for these works will take place on 28<sup>th</sup> April 25 to 30<sup>th</sup> April 25.

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation on **Monday**, **07** April **2025** and shall continue for a period of eighteen months unless extended by Order of the Secretary of State for Transport.

Exemptions to the order will be for authorised vehicles only, as listed below.

- Liveried Local Authority Vehicles (EQUANS / NELC)
- Emergency Vehicles (Fire, Police, Ambulance, Coast Guard)
- Authorised Contractors
