DNPH.HIT.20 APOLOGIES FOR ABSENCE

No apologies of absence were received for this meeting.

DNPH.HIT.21 DECLARATIONS OF INTEREST

There were no declarations of interest in relation to items on the agenda for this meeting.

DNPH.HIT.22 MINUTES

RESOLVED – That the minutes of the Portfolio Holder Housing, Infrastructure and Transport meeting on the 24<sup>th</sup> September 2025 be agreed as a correct record.

DNPH.HIT.23 PETITION – STOP PLANNED CHANGE IN PARKING REGULATIONS IN MILL ROAD AND SURROUNDING STREETS IN CLEETHORPES

The Portfolio Holder considered a petition to stop the planned change in parking regulations in Mill Road and the surrounding streets in Cleethorpes.

#### **RESOLVED -**

- 1. That the petition be received.
- 2. That the Portfolio Holder consult with officers on the various options in which to address the issues raised.

# DNPH.HIT.24 25-06 GRIMSBY TOWN CENTRE - VARIOUS STREETS - REVIEW OF EXISTING PARKING & LOADING PROVISIONS

The Portfolio Holder considered a report that proposed to amend the restrictions to vehicular access on George Street and waiting, stopping, loading and parking restrictions on George Street, New Street, Victoria Street West and Victoria Street South in accordance with the plans in Appendix 1, 2 and 3.

#### **RESOLVED -**

- 1. That the making of Traffic Regulation Orders to amend the restrictions to vehicular access on George Street and waiting, stopping, loading and parking restrictions on George Street, New Street, Victoria Street West and Victoria Street South in accordance with the plans in Appendix 1, 2 and 3 be approved.
- 2. That in the event there were unresolved material objections to the Order, these be referred back to the Portfolio Holder for Housing, Infrastructure and Transport for determination and a decision as to whether or not the Order be confirmed and executed.

REASONS FOR DECISION – The proposed changes to vehicle access and kerbside restrictions will reduce delays and disruptions to buses on George Street, Victoria Street West and Town Hall Street. The proposed restrictions will also provide a safer road environment on these streets by removing indiscriminate stopping, parking and loading and providing for these activities in designated bays.

OTHER OPTIONS CONSIDERED – Do nothing. This is not recommended given the bus operation issues identified.

### DNPH.HIT.25 TRAFFIC REGULATION ORDER 25-19 MARKET S STREET CLEETHORPES – VARIOUS RESTRICTIONS

The Portfolio Holder considered a report that proposed to introduce new Traffic Regulation Orders for various parking, loading and movement restrictions to support the pedestrianization of Cleethorpes Market Place, enhancing safety, accessibility, and community use of the area.

#### **RESOLVED -**

- 1. That the making of the required Traffic Regulation Orders (TROs) the effect of which will be to introduce the restrictions, as shown indicatively on the plans at Appendix 1-4 be approved.
- 2. That in the event there were unresolved material objections to the Orders, these be referred back to the Portfolio Holder for Housing, Infrastructure and Transport for determination and a decision as to whether or not the Order be confirmed and executed.

REASONS FOR DECISION – The introduction of appropriate on-street restrictions are proposed to support the pedestrianisation of the area and enable the Council to exercise its civil enforcement powers effectively. These measures are essential to maintaining a safe and accessible environment for all users of the space—particularly pedestrians and cyclists. This will enhance safety whilst also supporting the Council's broader goals of creating vibrant, people-focused public spaces.

OTHER OPTIONS CONSIDERED – Do nothing. This is not recommended, the project would have to be halted which could lead to the loss of the grant funding.
