6. Risk Response Measures

Major risks in the Humber region include flooding, severe weather, pandemics, and industrial accidents.

6.1 Flooding Response

In case of flooding:

- Tune into BBC Radio Humberside (95.9 FM) or Viking FM (96.9 FM) for updates.
- Contact Floodline (0845 988 1188) if in a flood-prone area.
- Move valuables and essential items upstairs if safe to do so.
- Place sandbags and other flood protection measures in place.
- Avoid walking or driving through floodwaters.

6.2 Weather Risks

- ****High Winds:**** Secure loose objects, avoid unnecessary travel, and stay indoors where possible.
- ****Heatwaves:**** Stay hydrated, avoid direct sunlight, and check on vulnerable individuals.

- ****Snow and Ice:**** Carry an emergency kit in vehicles, avoid unnecessary travel, and watch for signs of hypothermia.
