Cabinet Working Party

Terms of Reference

Draft Version

1. Purpose & Aim of the Working Party

At the Annual Meeting of Council held on 23rd May 2024, it was agreed to establish a Cabinet Working Party (CWP) to conduct a detailed review of the Council's approach to Street Scene, including Street Scene enforcement, with its findings and recommendations to be reported to Cabinet.

- To consider the Council's approach to cleansing of adopted highway and associated Council owned public open space, including statutory requirement and resource prioritisation, and report on findings and recommendations.
- To consider the Council's approach to street scene enforcement, including the ongoing transformation plan for these services. Areas for consideration will include waste/litter on private land, fly tipping, littering, fly posting and dog fouling and report on findings and recommendations.
- To consider the results of current trial schemes including seasonal resource in the resort, deep clean and the barrow operative schemes, to evaluate impact and make recommendations that could be integrated as part of any future approach.

The main purpose of the group is to make recommendations to Cabinet.

2. Role and Responsibilities of the Working Party

The role of the CWP will be to understand the issues around street scene cleanliness, the Council roles and how existing resources are prioritised to deliver an effective service within the current budget envelope.

The CWP will also consider and understand the issues arising from residents', landowner's and visitor's behaviors, and how to address these issues using engagement, investigation and enforcement tools.

A report on these findings, including an options appraisal with recommendations and budget considerations, will be presented to Cabinet for consideration.
