

The North East Lincolnshire Borough Council (Cleethorpes Parking Scheme) (No. 20-15A) Order 2023

Notice is hereby given that on 22nd August 2025 North East Lincolnshire Borough Council made the above Traffic Regulation Order under powers contained in the Road Traffic Regulation Act 1984 the effect of which will be to:-

1. Introduce "24 Hour Prohibition of Waiting" restrictions at the following locations in Cleethorpes:

Crow Hill Avenue	Kew Road
Dolphin Street	West Street

2. Introduce "24 Hour Prohibition of Loading" restrictions at the following locations:

The north-east end of Elm Road, Cleethorpes.

Mill Road, Cleethorpes on both side of the road between St Peters Avenue and Fair View Avenue.

3. Introduce "1-hour No Return within 1-hour Limited Waiting Parking Places which operate from Monday-Sunday 8am-6pm" at the following locations:

The north end of Cosgrove Street, Cleethorpes

The south-east end of Glebe Road, Cleethorpes

4. Introduce "2-hour No Return within 2-hour Limited Waiting Parking Places which operate from Monday-Sunday 8am-6pm" at the following location:

The north-west end of West Street, Cleethorpes

5. Introduce a "Permit Holders Only Parking Zone which operates Monday-Sunday 8am-6pm" at the following locations in Cleethorpes:

Charles Street	Dolphin Street	Kew Road
Cosgrove Street	Fair View Avenue	Mill Place
Crow Hill Avenue	Glebe Road	West Street

The table below details the permit charges in relation to Permit Holder Parking Places:

Type of Permit	Cost (per annum)
Private Residents Permit	£50
Business Permit	£150
Disabled Resident	Free of charge
Carers Permit	Free of charge
Daily Visitor Permits (book of 8)	£24
Motorcycles	N/A No application/permit required

6. Introduce a "Loading Only Bay Area which operates from Monday-Sunday 8am-6pm" at the following location:

The north-west end of West Street, Cleethorpes

The Order will come into force on the **1st December 2025**.

If any person wishes to challenge the validity of the Order, or any provision contained in it, on the grounds that it is not within the powers conferred by the Act, or that any requirement of the Act or any instrument made under it has not been complied with may, within 6 weeks from the date on which the Order was made, apply for the purpose to the High Court.
