

Operational Officer Decision Record

1. Subject and details of the matter (to include reasons for the decision and detail of any previous cabinet decision)

Discretionary Rate Relief is awarded to qualifying ratepayers under Section 47 (6A) of the Local Government Finance Act 1988. With effect from 01/04/24 Section 47 (6A) of the Local Government Finance Act 1988 has been amended to remove restrictions on the backdating of decisions in relation to Non-Domestic Rates Discretionary Relief. Therefore, from 01/04/24, the Council needs to update their Non-Domestic Discretionary Policy to include the backdating limits of discretionary rate relief and the notice period for the removal of a discretionary rate relief.

The reason for the decision below is to reduce financial burden on the Councils budget in relation to previous tax years. We are proposing that the backdating policy remains in line with the Councils current practice to restrict backdating to the beginning of the financial year in which the decision is made.

2. Decision being taken

The decision is to continue to restrict the backdating of discretionary relief to the beginning of the tax year in which the decision is made and to include a notice period of one month if the Discretionary Rate Relief ceases. The Policy will be updated accordingly to reflect this.

This will encourage ratepayers to apply as early as possible in the year in which they wish to claim relief.

3. Anticipated outcome(s)/benefits

To continue to award discretionary relief to support businesses in North East Lincolnshire in line with the existing policy.

4. Details of any alternative options considered and rejected by the officer when making the decision

Alternative option rejected was to award discretionary relief in accordance with the statute within the limitations act which is to backdate 6 years. However, this leaves the council open to large budgetary deficit issues for previous years.
