Notice is hereby given that North East Lincolnshire Borough Council propose to make a Road Traffic Regulation Order under powers contained in the Road Traffic Regulation Act 1984 the effect of which will be to:-

1. Introduce "Prohibition of Waiting: No Waiting at Any Time" restrictions at the following locations in Cleethorpes:

Market Street

Cross Street

Osborne Street

Short Street

2. Introduce "No Stopping except Taxis Monday to Sunday 7pm – 8am" restrictions at the following location:

Cross Street

3. Introduce "Prohibition of Loading: No Loading at Any Time" at the following location:

Dolphin Street

4. Introduce "Prohibition of Waiting at Any Time and Prohibition of Loading at Any Time Except in Signed Bays" at the following locations:

Cosgrove Street

Cross Street

Market Street

Mill Place

Osborne Street

Short Street

5. Introduce "Limited Waiting Monday to Sunday 8am – 7pm, 30 minutes no return within 1 hour" at the following locations in Cleethorpes:

Cross Street

6. Introduce "Disabled Persons Parking Only Monday to Sunday 10am – 5am" at the following locations:

Market Street

Short Street

7. Introduce "Goods Vehicle Loading Only Monday to Sunday 5am – 10am" at the following locations:

Market Street

Short Street

8. Introduce "Goods Vehicle Loading Only" at the following location:

Market Street
