Award Contracts for the Purchase of a Fleet of New Ride On Mowers

The Council intends to purchase a fleet of 9 (nine) New Ride on Mowers to replace existing fleet machinery.

No additional Desirable Requirements are being taken up as all requirements needed are included in the cost of the machines.

The whole life of the contracts for all of the fleet machines is: £221,715.00

This is split across the lots as follows:

Lot 1: Supply of one (1) X New Ride on Mower with High Lift Box – £14,987.00

Lot 2: Supply of two (2) New Ride On Mowers with Electric Tip Box – £15,054.00

Lot 3: Supply of four (4) New Ride On Cylinder Mowers – £175,524.00

Lot 4: Supply of Two (2) New Ride On Zero Turn Mowers – £16,150.00

Approval to procure:

Approval to procure Cabinet Decision DN16 On 17th July 2024 Cabinet considered a report from the Portfolio Holder for Environment and Net Zero seeking approval to commence the procurement exercises for fleet items over a two-year period.

RESOLVED -

- 1.That the commencement of procurement exercises for fleet items over a two-year period be approved.
- 2.That the Director of Economy, Environment and Infrastructure in consultation with the Portfolio Holder for Environment and Net Zero be delegated authority to award contracts following the required procurement exercises for the purchase of the replacement fleet items.
- 3. That the Assistant Director Law and Governance (Monitoring Officer) be authorised to complete and execute all legal documentation arising.

This tender for a fleet of Mowers is one of these required procurement exercises for purchase of replacement fleet items.

An open lotted tender was conducted through the council's procurement portal YORtender, reference: 95694

It was advertised on the government's Find a Tender Service under ref no: 2025/S 000-004814.

Eight tenderers submitted tenders, bidding across 4 different lots:

- Lot 1: Supply of one (1) X New Ride on Mower with High Lift Box 7 bids
- Lot 2: Supply of two (2) New Ride On Mowers with Electric Tip Box 4 bids
- Lot 3: Supply of four (4) New Ride On Cylinder Mowers 5 bids
- Lot 4: Supply of Two (2) New Ride On Zero Turn Mowers 6 bids

Following the conclusion of the evaluation process described in Appendix 1 (closed), the Most Economically Advantageous Tender for each of the Lots 1 -4 has been identified as that submitted by Ernest Doe & Sons Ltd and so approval is sought to award the contract for the purchase of a fleet of New Ride on Mowers to Ernest Doe & Sons Ltd.

2. Decision being taken

That the Director of Economy, Environment and Infrastructure in consultation with the Portfolio Holder for Environment and Net Zero awards the contracts for a Fleet of 9 (nine) New Ride on Mowers on the following Lots to Ernest Doe & Sons Ltd:

- Lot 1: Supply of one (1) X New Ride on Mower with High Lift Box
- Lot 2: Supply of two (2) New Ride On Mowers with Electric Tip Box
- Lot 3: Supply of four (4) New Ride On Cylinder Mowers
- Lot 4: Supply of Two (2) New Ride On Zero Turn Mowers

3. Anticipated outcome(s)/benefits

The contracts for the purchase of a Fleet of 9 (nine) New Ride on Mowers to Ernest Doe & Sons Ltd will improve fleet efficiency and reduce the environmental impact of the fleet in line with the Council's Carbon Roadmap. This new contract will avoid the impact on revenue budgets of increased costs of hiring machinery. The mower fleet enables the Council to meet its commitments under Greener Future - Looking After and Protecting our Parks and Open Spaces.

4. Details of any alternative options considered and rejected by the officer when making the decision

Options Appraisal:

OTHER OPTIONS CONSIDERED – Do nothing. This is not a viable option however as aging fleet would mean machinery would consistently break down and require the Council to hire machines to cover the downtime. Due to increased impacts on revenue budgets this would not be cost effective and is not a viable option. There would also be an impact on the Council's Corporate image as increased downtime would lead to uncut grass and a rise in complaints about the appearance and upkeep of the Borough.

The contract for the purchase of the fleet follows an open lotted tender process. This supports delivery of value for money principles. The new contract is expected to improve efficiency and avoid the impact on revenue budgets of increased costs of hiring machinery. The capital purchase costs are covered within the fleet replacement project, which forms part of the approved capital programme.
