

Officer Decision Record - Key Decision

2. Subject and details of the matter (to include reasons for the decision)

In 2018, the Council entered into a contract with City of Doncaster Council to deliver a range of environmental patrols e.g. litter, Public Space Protection Orders (PSPO) and smokefree through a third-party provider. The enforcement functions in relation to dog fouling, littering, smoke free and PSPOs are set out in the Environmental Protection Act 1990, Anti-Social Behaviour, Crime and Policing Act 2014, Clean Neighbourhoods and Environment Act 2005 and Health Act 2006.

A report was presented to Cabinet on the 8th March 2023, seeking approval to:

- Extend the current contract with Doncaster Council and their delegation of enforcement powers to undertake environmental patrols for a further 2 years with a possible two further 1-year extensions, therefore being a 2 + 1 + 1 contract extension.
- 2. Authorises the Director for Economy, Environment and Infrastructure, in consultation with the Portfolio Holder for Safer and Stronger Communities, to award any contract extensions or variations.

The current contract was extended by 2 years in 2023 to December 2025, therefore a further 1-year extension is now sought of the possible two 1-year extensions that is

possible under the terms of the agreement. This will take the contract to December 2026. At that point one further 1-year extension would be available.

Approval is now sought to:-

1. Extend the length of the current 2-year contract by 1 year, as above.

3. Decision being taken

That the Director for Economy, Environment and Infrastructure, in consultation with the Portfolio Holder for Safer and Stronger Communities extends the current contract with Doncaster Council by a period of a further 1 year to December 2026.

5. Anticipated outcome(s)/benefits

The Council are currently contracted with City of Doncaster Council to deliver a range of environmental patrols through a third-party provider, Waste Investigations and Enforcement Services (WISE) to December 2025.

This decision to extend the contract by one year will enable the Council to have an operational litter, Public Space Protection Orders (PSPO) and smokefree enforcement provision with coverage across the borough, including the ability for direct tasking into areas of concern mobilised delivered by WISE through till December 2026.

6. Details of any alternative options considered and rejected by the officer when making the decision (this should be similar to original cabinet decision)

The following alternative options have been considered:

Option 1 – Do Nothing

If no action is taken the contract will expire in December 2025. This will mean that the council will have no directed operational ability to enforce the provisions around litter, PSPO and smokefree enforcement. Therefore, this is not considered viable.

Option 2 – Serve Notice to terminate agreement

The contract requires 6 months' notice of our intention to withdraw from the agreement. Following service of this withdrawal notice, the contract would expire in December 2025. This will mean that the council will have no directed operational ability to enforce the provisions around litter, PSPO and smokefree enforcement. Therefore, this is not considered viable.

Option 3 – Contract another provider

With 6 months remaining, this is not considered sufficient time to procure alternative arrangements. Therefore, this is not considered viable.

Option 4 - Terminate contract and deliver services in house

With 6 months remaining, this is not considered sufficient time to create and deliver an in-house delivery team. Therefore, this is not considered viable.

Any enforcement can attract negative publicity, and this area of environmental enforcement is often subject to media interest for a period of time. However, these arrangements with a third party provider have been in place since 2018 and therefore not considered new.

Regular communications on the outcomes achieved through this contract are produced in consultation with the Communications Team and therefore the council will continue to respond showing the positive effect of this enforcement work on the place of North East Lincolnshire in order to inspire behaviour change around littering, compliance with PSPO and smokefree provisions.

Key Decisions are defined in the Constitution as:

A decision (whether taken collectively or individually by members) which is likely:

- (i) to result in the Council incurring expenditure which is, or the making of savings which are, significant having regard to the Council's budget for the service or function to which the decision relates; or

A decision will be considered financially significant if:
