The North East Lincolnshire Borough Council (Off-Street Parking Places) Order 2022 (Amendment No.10 2025)

North East Lincolnshire Council, hereinafter referred to as “the Council”, in exercise of powers under Sections 32 and 35 of the Traffic Regulation Act 1984 as amended (hereinafter referred to as “the 1984 Act”) and under the Traffic Management Act 2004 as amended (hereinafter referred to as “the 2004 Act”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. Commencement and Citation

- 1.01 This Order may be cited as “The North East Lincolnshire Borough Council (Off-Street Parking Places) Order 2022 (Amendment No.10 2025) it amends the North East Lincolnshire Borough Council (Off-Street Parking Places) Order 2022 and shall come into operation on the 16th day of October 2025.

2. Amendments

The North East Lincolnshire Borough Council (Off-Street Parking Places) Order 2022 (“the Original Order”) shall be amended by

- 2.01 Deleting the wording in columns 4, 5, and 6 in row 39a to the table in Schedule 3 to the Original Order (amended by the Third Amendment Order) and replacing it with wording shown in Schedule 1 to this Tenth Amendment Order.

Save as amended by this Tenth Amendment Order, the First Amendment Order, the Second Amendment Order, The Third Amendment Order, the Fourth Amendment Order, the Fifth Amendment Order, the Sixth Amendment Order, the Seventh Amendment Order, the Eighth Amendment Order, the Ninth Amendment Order, the Original Order remain in full force and effect.

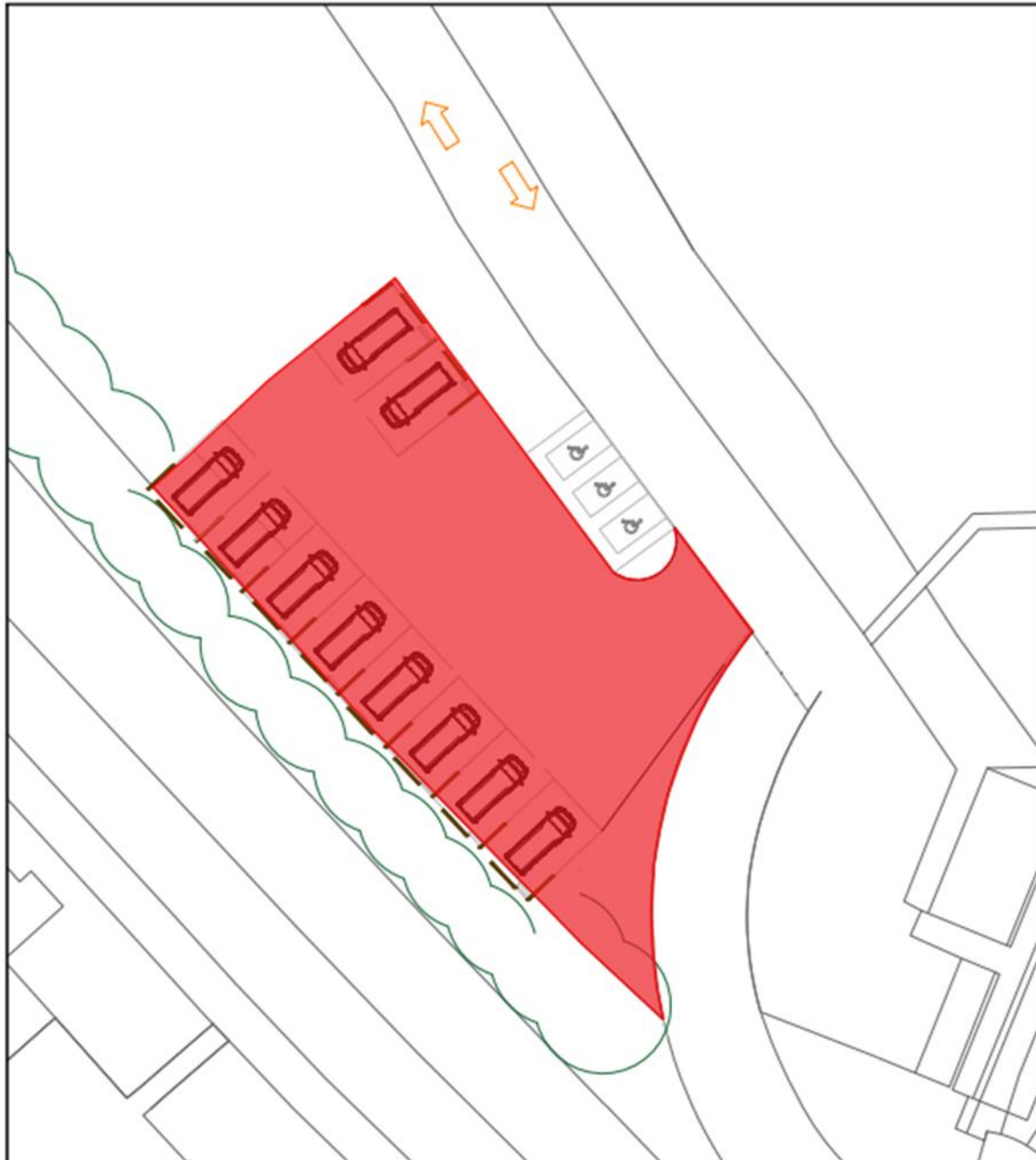
