ROAD TRAFFIC REGULATION ACT 1984 (SPECIAL EVENTS) – SECTION 16A
REMEMBRANCE DAY SERVICE 2025 – WALTHAM
(TEMPORARY PROHIBITION OF TRAFFIC – TTRO 25-181) ORDER 2025

WHEREAS the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Section 16 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 hereby make the following Order the effect of which will be that **no person shall cause or permit** any motor vehicle or cycle to **PROCEED** along the below sections of carriageway between 10:00hrs and 14:00hrs on **SUNDAY 09TH NOVEMBER 2025**. The extent of the closure will be:

- CHEAPSIDE – Part Length from its junction roundabout with BRIGSLEY ROAD, in a easterly direction, for a distance of 140 metres:
- KIRKGATE – Full extent of KIRKGATE
- NEW ROAD – Part length from its junction with KIRKGATE, in a south easterly direction, for a distance of 85 metres.
- HIGHSTREET – Part length from its junction with KIRKGATE, in a south westerly direction, for a distance of 280 metres.
- BARNOLDBY ROAD – Part length from its junction with HIGHSTREET, in a westerly direction, for a distance of 130 metres

Alternative route: BARNOLDBY ROAD, WESTFIELD ROAD (reverse route applies)

This temporary prohibition is required to allow safe facilitation of the Remembrance Day Service at Waltham, Grimsby.

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation on **Sunday, 09 November 2025** and shall continue for a period of three days unless extended by Order of the Secretary of State for Transport.

Exemptions to the order will be for authorised vehicles only, as listed below.

- Emergency Vehicles (Fire, Police, Ambulance, Coast Guard)
- Authorised Contractors

The Order may be cited as "The North East Lincolnshire Borough Council, Road Traffic Regulation Act 1984 (Special Events) – Section 16A , Remembrance Day Service, Waltham (Temporary Prohibition Of Traffic – TTRO 25-181), Order 2025"
