

**The North East Lincolnshire Borough Council**  
**(Riverhead, Grimsby) (Waiting, Loading & Parking)**  
**(No.25-06A) Order 2025.**

Notice is hereby given that North East Lincolnshire Borough Council propose to make a Road Traffic Regulation Order under powers contained in the Road Traffic Regulation Act 1984 the effect of which is to:

1. Introduce “24 Hour Prohibition of Waiting” restrictions at the following locations in Grimsby:  
George Street                  New Street                  Victoria Street West
2. Introduce “24 Hour Prohibition of Loading” restrictions at the following locations:  
George Street                  New Street                  Town Hall Street                  Victoria West Street
3. Introduce “24 Hour No Stopping Except Taxis restrictions” at the west end and north-east end of Victoria Street West, Grimsby.
4. Introduce “1-hour No Return within 1-hour Limited Waiting Parking Places which operate from Monday-Saturday 8am-6pm” at the north-east end of Victoria Street South, Grimsby.
5. Introduce a “24 Hour Disabled Badge Holders Only Parking Area” at the south-east end of Victoria Street South, Grimsby.
6. Introduce “24 Hour Loading Only Bay Areas” at the west end of Victoria Street West, Grimsby.
7. Introduce a “Loading Only Bay Area which operates from Monday-Saturday 8am-6pm” at the north-east end of Victoria Street West, Grimsby.
8. The restrictions are subject to exemptions, as set out in the Order
