

# Officer Decision Record - Key Decision

Key decisions taken by an officer are subject to the 5 day call in period from circulation to Members, and therefore the decision will be released for implementation following the call-in period and no call in being received

## 1. Cabinet date and copy resolution this key decision relates to

Cabinet approval of 9<sup>th</sup> March 2022 approved a programme of works in relation to the development of High Needs places utilising the High needs provision capital allocation grant (HNCPA).provided to NELC, which supports the provision of new places and improve existing places.

In February 2022 cabinet approved acceptance of the Delivering Better Value revenue grant part of which aimed to improve skill and knowledge development of education settings. It authorised that the Director of Children's Services, in consultation with the Portfolio Holder for Children and Education, be authorised to ensure that all necessary actions are carried out in order to co-ordinate and implement the Delivering Better Value programme.

On 13<sup>th</sup> March 24 Cabinet approved the three Special Educational Needs and Disability and Alternative Provision (SENDAP) strategies and resolved that authority be delegated to the Executive Director for People, Health and Care in consultation with the Portfolio Holder for Children and Education to oversee the delivery of the plans and activities identified and carry out all ancillary activity reasonably arising. The SENDAP Sufficiency Strategy included the creation of minimum of 75 resource specialist provision additional places in North East Lincolnshire.

All of this activity aligns to the national Department of Education direction of travel for stronger inclusive offers in mainstream education, to support sustainability across the SEND system nationally.

### 2. Subject and details of the matter (to include reasons for the decision)

The Council have worked in partnership with Enquire Learning Trust and Welholme Academy to agree the development a 12 place Resource Specialist Provision (RSP) at Welholme for children with Special Educational Needs and Disabilities (SEND) who have an education, health and care plan (EHCP).

The Academy hope to deliver the RSP in a repurposed area of the primary school. The children will be phased in starting with potentially 6 places and working to open the full 12 places. High Needs capital grant funding will be used to create a dedicated RSP. The RSP is aiming to open in September 2026 subject to the Department for Education (DfE) significant change process approval and building refurbishment works timescales which have yet to be confirmed.

The refurbishment works are being designed and agreed. Specifications will be developed to undertake a procurement exercise. The spaces will need configuration to create the RSP space, which will also be funded, creating new teaching and learning spaces, toilets, sensory space and outside area developed for recreation included. High Needs capital grant funding has been allocated for the procurement to be undertaken to secure a contractor to undertake the works. The works would be managed by the Council. The capital allocated is £500,000.

The capital works to create an environment that's fit for purpose for the RSP will ensure value for money to meet the needs of 12 4-11 year olds (Reception, Key stage 1 and 2) with speech, language and communication primary need.

Utilising revenue funding from the Delivering Better Value project, the Council are also supporting development with training in speech language and development skills and knowledge to further support the Academy staff to meet the needs of children with speech, language and communication needs including non verbal children. This will

ensure a whole school environment with staff who are skilled to meet the identified needs of the young people attending the RSP and mainstream school.

### 3. Decision being taken

That the Director for Children's Services in consultation with the Portfolio Holder for Children and Education:

- 1. Approves undertaking a procurement exercise to secure a provider to undertake the necessary refurbishment works;
- 2. Approves entering into an agreement with the Enquire Trust to develop a 12 place RSP at Welholme Academy site for children with SEND who have an education, health and care plan (EHCP).

### 5. Anticipated outcome(s)/benefits

This decision supports a school expansion scheme as captured within the Schools Capital Programme, which will increase the capacity for SEND school places within the Council's area.

The RSP in local schools will secure greater value for money from the High Needs Block of the Dedicated Schools Grant (DSG) whilst also seeking to reduce transport costs. Per place, the RSP's will be a lower cost than out of area placements and will therefore also contribute to future revenue cost avoidance, reducing and managing the DSG deficit. The children identified are currently children who don't currently have provision within North East Lincolnshire, resulting in their education being away from their families and communities due to the requirement for specialist education settings.

Whilst impacting on the DSG funding initially, the RSP will contribute to supporting sustainability of DSG, as outlined and accepted by the DfE within the Council's DSG Management Plan.

6. Details of any alternative options considered and rejected by the officer when making the decision (this should be similar to original cabinet decision)

**Do nothing option** would not meet identified SEND provision needs and have a negative impact on future revenue funding. Significant costs will be incurred as well as reputational and potentially legal negative impacts as the RSP project development would cease; children and young people would have to be educated in other communities and young people with education, health and care plans (EHCP's) would be sent out of the borough. This option is therefore not considered viable.

To not develop the RSP and use external provision this would not realise the benefits to children being educated in their own community, resulting in significant negative reputational impact. This option will not contribute to achieving the places identified in the SENDAP Sufficiency Strategy or cost savings required as outlined in Delivering Better Value report, both resulting in a financial impact to the Council. This option is therefore not considered viable.

There is a Financial risk to the Council should the RSP project with identified pupil places not be agreed. Currently the DSG pressure is permissible by Government and a plan to reduce this (Deficit Management plan) has been agreed for SEND High Needs block.

Further risk assessments will be undertaken by NELC and the contractor for the works which could impact on opening date and operational costs impacted on.
