The North East Lincolnshire Borough Council (Off-Street Parking Places) Order 2022 (Amendment No.11) Revocation Order 2025

North East Lincolnshire Council, hereinafter referred to as “the Council”, in exercise of powers under Sections 32 and 35 of the Traffic Regulation Act 1984 as amended (hereinafter referred to as “the 1984 Act”) and under the Traffic Management Act 2004 as amended (hereinafter referred to as “the 2004 Act”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. Commencement and Citation

- 1.01 This Order may be cited as “The North East Lincolnshire Borough Council (Off-Street Parking Places) Order 2022 (Amendment No.11) Revocation Order 2025, it amends the North East Lincolnshire Borough Council (Off-Street Parking Places) Order 2022 and shall come into operation on the 19 day of December 2025.

2. Amendments

The North East Lincolnshire Borough Council (Off-Street Parking Places) Order 2022 (“the Original Order”) shall be amended by

- 2.01 Removing rows 19, 19a and 19b in the table in Schedule 3 to the Original Order shown in Schedule 1 to this Eleventh Amendment Revocation Order.
- 2.02 Plan Offstreet-2022-19 attached to this Eleventh Amendment Revocation Order will be removed from the Original Order.
- 2.03 Schedule 2 to the Original Order shall be amended by removing Fishing Heritage Centre, Grimsby, as shown shaded red on drawing no. Offstreet-2022-19 at Schedule 2 of this Eleventh Amendment Revocation Order.

Save as amended by this Eleventh Amendment Revocation Order, the First Amendment Order, the Second Amendment Order, the Third Amendment Order, the Fourth Amendment Order, the Fifth Amendment Order, the Sixth Amendment Order, the Seventh Amendment Order, the Eighth Amendment Order, the Ninth Amendment Order, the Tenth Amendment Order, the Original Order remain in full force and effect.

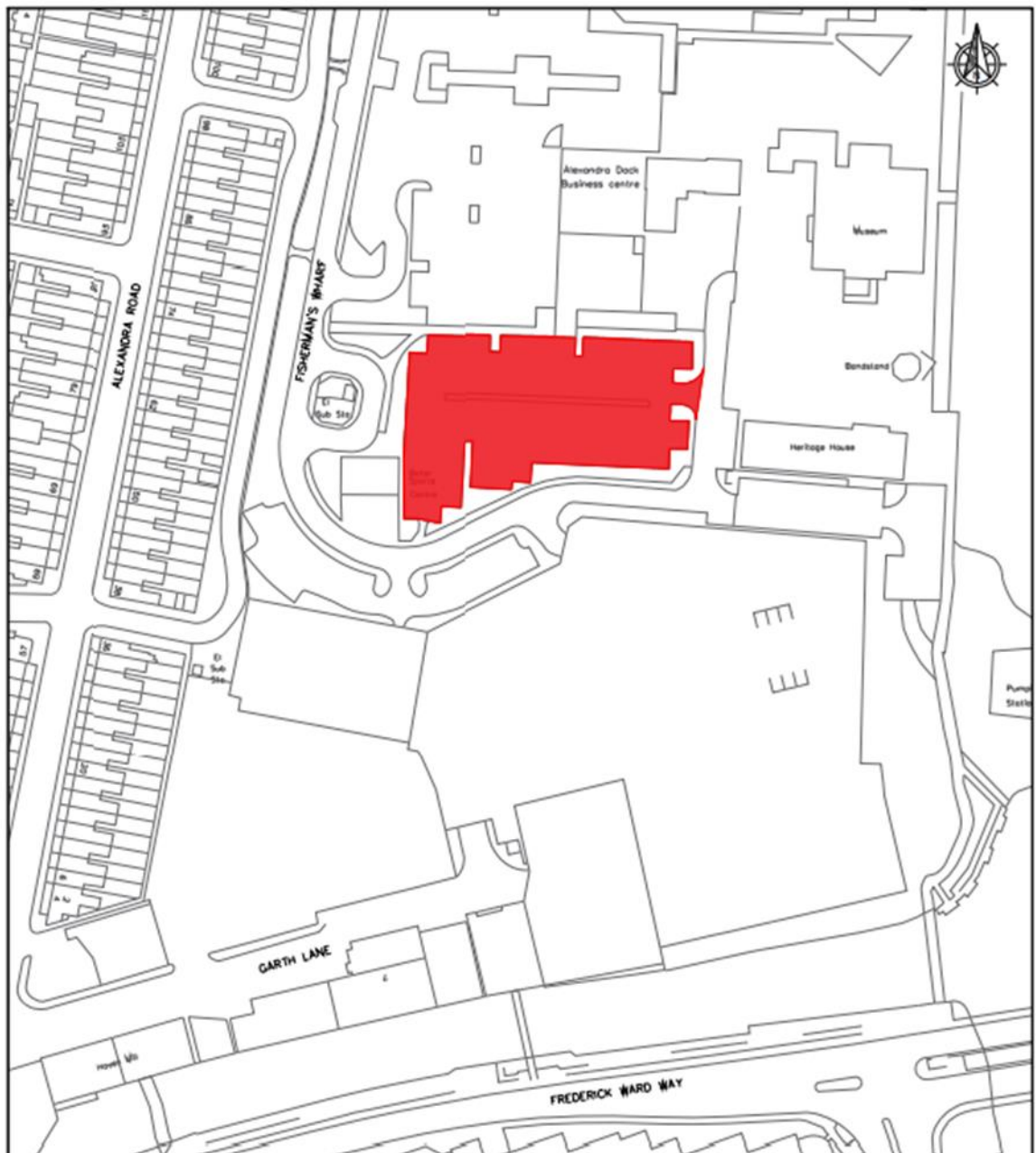
