NORTH EAST LINCOLNSHIRE - OUR BOROUGH IN CONTEXT



- Unitary authority on the south bank of the River Humber, with 15 ward areas.
- Total Population: 159,911 (ONS mid year population estimates June 2024).
- 15-19 population: 9,201.
- 29.8% of children under 16 living in families with absolute low income, compared to 19% nationally and 34.5% of children living in families with relative low income compared to 22.1% nationally (DWP 2023/24).
- Significant differences in the proportion of children living in poverty in the most deprived wards compared to the most affluent wards.
- 34% of state funded secondary school pupils known to be eligible for free school meals compared to 26% nationally (DfE Pupil Characteristics 24/25).
- 35.8% of students achieved grade 5 or above in both English and Maths GCSEs at the end of key stage 4 compared to 41.5% of students nationally (GOV.UK).

INTRODUCTION

Participating in education, training or employment with accredited training brings benefits not only for young people, but also to the economy and wider society within which they reside.

The Department for Education requires all young people to participate in education, training or employment with training until at least their 18th birthday, as set out in their “Raising of the Participation Age” statutory guidance**, and is categorised by young people who are:

- **Meeting the duty to participate** in a learning opportunity.
- **Not participating** in a learning opportunity.
- **Working towards participation.**
- **Taking a Temporary Break from Learning.**

(Temporary break from learning includes young people who are temporarily not available to the labour market for reasons such as pregnancy, being a parent and/or illness).

Local authorities have a critical role to play in supporting young people to access education and training (outlined in the Education & Skills Act 2008) and therefore in understanding the characteristics and current activity of the young people in their area.

The information within this report offers a destination snapshot of data collected annually on 31st January as part of an Annual Activity Survey and relates to year 11 leaver destinations as of 1st November. The data relates to young people who were registered at a school or other educational establishment in North East Lincolnshire (including alternative provision, pupil referral units, independent schools and custodial institutions) and also young people not registered at a school but resident in North East Lincolnshire as of 31st May 2024. The exception being children in our care where the full cohort is reported upon.


The report also includes comparative data for young people who completed year 11 in 2023.







Key Points

A total of **2023** young people completed year 11 in 2024, which is **130** more than in 2023 when the cohort was **1893**.

91.9% of the 2024 leaver cohort were **meeting the duty to participate** through engaging in a learning opportunity. “Learning opportunities” include a full-time place at an establishment of further education (for example school sixth form, sixth form college or further education college), employment with accredited training, traineeships, apprenticeships and ESFA funded work-based learning.

Of the young people meeting the duty to participate **90.7%** remained in full-time education, **6.1%** were in employment with accredited training and **3.2%** were on work-based learning programmes.

Of the young people remaining in full-time education: 48.2% chose a further education college, 43.8% chose a sixth-form college, 5.8% opted for a school sixth-form, 1.1% were accessing a specialist post 16 college and 1.1% were accessing other post 16 full-time education, which includes any students repeating year 11.

7.2% of the 2024 leaver cohort were **not meeting the duty to participate** in a learning opportunity, which includes young people who are not in employment, education or training (NEET) and also young people in destinations that are not compliant under Raising of the Participation Age statutory guidance, for example young people in employment without training.

Of the young people not meeting the duty to participate, 102 were not in employment education or training (NEET), 2 could not be contacted and 3 were no longer living in North East Lincolnshire. 2 young people were in part-time learning and 36 were in employment without or with non-accredited training.

0.6% of the 2024 leaver cohort were **working towards participation** through undertaking re-engagement activities designed to move them closer to learning opportunities, and **0.3%** were unavailable to the labour market therefore **taking a temporary break from learning** for reasons such as pregnancy, being a parent and/or illness.

By way of comparison, the 2023 leaver cohort offers a slightly higher percentage of the overall cohort meeting the duty to participate at **92.1%**, however the actual number of young people participating has increased from 1744 in 2023 to 1858 in 2024.


DESTINATIONS OF 2024 LEAVERS ELECTIVELY HOME EDUCATED

The tables below show the destinations and comparative data of the 2024 and 2023 year 11 leavers who were home educated.

Elective home education is a term used to describe a choice by parents to provide education for their children at home or in another way, instead of sending them full-time to a statutory education provider. This is different to education provided by a local authority other than at a school, for example for children who are too ill to attend.




83 young people who reached statutory school leaving age in 2024 were electively home educated and resident in North East Lincolnshire, which equates to 4.1% of the full 2024 leaver cohort. This is an increase compared to the 67 2023 leavers who represented 3.5% of the full 2023 leaver cohort.

63.9% were **meeting the duty to participate** with the majority opting to continue their studies in full-time education at a further education college, which was also the case for 2023 leavers.

27.7% were not meeting the duty to participate. Of those not meeting the duty to participate, 19 were not in employment education or training (NEET), 2 were participating in employment, education or training activities that were not compliant under Raising of the Participation Age statutory guidance and a further 2 could not be contacted, 1 of whom due to having left the area.

7.2% were working towards participation by undertaking re-engagement activities, which is an increase of 5 young people when compared to 2023 leavers, and **1.2% were not available to the labour market**, therefore **taking a temporary break from learning**.


A child is looked after by a local authority if he or she has been provided with accommodation for a continuous period of more than 24 hours, in the circumstances set out in sections 20 and 21 of the Children Act 1989 or is placed in the care of a local authority by virtue of an Order made under part IV of the Act.

PLEASE NOTE: Whilst the wider Learning & Skills Statement reports on children educated in North East Lincolnshire the figures below represent **ALL** children in our care from the 2024 and 2023 leaver cohorts.

Of the 39 2024 leavers, 19 were educated in North East Lincolnshire and 20 were educated out of area.



39 young people were in our care as of their official school leaving date in 2024, which is 5 more young people than in 2023.


79.5% of our young people were **meeting the duty to participate** through being engaged in a Raising of the Participation Age compliant activity, which is a significant increase when compared with the 64.7% of 2023 leavers.

As with 2023 leavers, the preferred route for young people in our care meeting the duty to participate was full-time education at a further education college, however more young people also progressed onto sixth-form college and school sixth-form this year.

Of our young people remaining in full-time education, 54.9% chose a further education college, 29.0% chose a sixth-form college, 12.9% opted for a school sixth-form and 3.2% was accessing a post 16 specialist college.

20.5% of young people in our care were **not meeting the duty to participate** and of these 5 were not in employment education or training (NEET), 2 were in employment without training and 1 was in part-time learning. There has been a 50% reduction in the number of young people in our care who became NEET when compared with 2023 leavers.


Education Health & Care Plans (EHCPs)



110 young people from the 2024 leaver cohort had an Education Health & Care Plan (EHCP) which represented 5.4% of the full cohort. This is a slight decrease compared to 2023 leavers when 109 young people had an EHCP which represented 5.8% of the cohort.


89.1% were meeting the duty to participate which is the same number as for 2023 leavers. The majority remained in full-time education, with further education proving most popular at 39.9%, followed by school sixth-form at 21.4%, post 16 specialist college at 17.3% then sixth-form college at 11.2%. A further 10.2% were

participating in other learning or training such as ESFA funded study programmes or bespoke education packages.

10.9% of 2024 leavers with an EHCP were **not meeting the duty to participate**, 10 of whom were not in employment education or training (NEET), 1 was in part-time learning and 1 was in employment without training. The number of young people not in employment, education or training is almost identical to 2023 leavers.

There were significantly more males than females with an EHCP from the 2024 leaver cohort which correlates with data for 2023 leavers.

The data below shows the destinations of 2024 leavers with an EHCP who reached compulsory school leaving age in 2024, compared to those who left in 2023:




SEN Support

The data below shows the destinations and comparative data of the 2024 and 2023 year 11 leavers who were educated in North East Lincolnshire and identified as SEN support during census data collection from schools/academies in January 2024.

The SEN and Disability Code of Practice (2014) identifies a young person being SEN support when they have special educational needs (SEN) that requires schools to take action to remove barriers to learning and put effective SEN SUPPORT in place.



261 young people from the 2024 leaver cohort were identified as SEN support by their school/academy in the January 2024 census collection, which represented 12.9% of the full cohort. This is an increase compared to 2023 leavers, when 212 young people were SEN support, which represented 11.2% of the full cohort.


87.7% of 2024 leavers identified as SEN support were meeting the duty to participate, which is higher than last year's 80.7%. The most popular option was full-time education at a further education college followed by sixth-form college, which correlates with data for 2023 leavers.

11.9% were not meeting the duty to participate, 20 of whom were not in employment, education or training (NEET) and 11 were in employment without training. This is a reduction compared to 2023 leavers data when 17.5% of the cohort were not meeting the duty to participate and of those 33 were not in employment, education or training.

0.4% were not available to the labour market, so taking a **temporary break from learning**, which is the same figure as 2023 leavers.

As with young people with an Education, Health & Care Plan there were more males than females who were identified as SEN support.

The data below shows the destinations of 2024 leavers who were identified as SEN support when the January 2024 census data was collected by schools/academies, compared to those who left in 2023:



EXECUTIVE SUMMARY

A total of **2023** young people were educated in North East Lincolnshire and reached compulsory school leaving age in 2024.

- **91.9%** of the 2024 leaver cohort were **meeting the duty to participate** in a learning opportunity under Raising of the Participation Age statutory guidance, however overall **94.4%** of the cohort were participating when including those in non-compliant Raising of the Participation Age activities.
- The most **popular choice** of those meeting the duty to participate was **full-time education**, with further education college being the preferred pathway, followed by sixth-form college.
- There was a **1.9%** increase in young people accessing **work-based learning programmes** compared to 2023 leavers.
- Of the young people **not meeting the duty to participate** **70.3%** were not in employment, education or training (NEET). A further **26.2%** were in non-compliant Raising of the Participation Age activities, such as employment without training or part-time learning.
- There were more males than females in the 2024 leaver cohort and in relation to **individual characteristics** more males: were in our care, had an Education Health & Care Plan or were identified as SEN Support, however more females were electively home educated.
- **63.9%** of **electively home educated** young people were meeting the duty to participate in a learning opportunity. A further **4.8%** were engaged in non-compliant Raising of the Participation Age activities.
- There was a significant increase of **young people in our care** who were meeting the duty to participate, rising from **64.7%** in 2023 to **79.5%** in 2024. Overall **87.2%** of the cohort were participating, which includes those in non-compliant Raising of the Participation Age activities.
- **89.1%** of young people with an **Education Health & Care Plan** were meeting the duty to participate and a further **1.8%** were in non-compliant Raising of the Participation Age activities.
- Similarly the majority of young people identified as **SEN Support** were meeting the duty to participate **87.7%** with a further **4.2%** in non-compliant Raising of the Participation Age activities.
