### Safeguarding Children Partnership Board 06/01/2026

It was another fully packed agenda which reflected the level and pace of partnership activity since the last Board in October 2025. It was also an opportunity to recognise and celebrate the fantastic work by the partnership in delivering against the Safeguarding Children Partnership (SCP) priorities and core functions over the last year in improving outcomes for our children.

The SCP welcomed Jade Clarke as the SCP Business Support Specialist, a fantastic addition to the SCP Team.

**Key areas for discussion and consideration are summarised below.**

#### NELC SCP Performance Dashboard

The Board considered the latest dashboard which supports the SCP to understand the effectiveness of safeguarding arrangements. The dashboard is greatly informing the work of the Safeguarding Practice Learning and Development Group and the Safeguarding Performance Practice Assurance Group and SCP priority delivery groups. An example of how data is informing practice is the number of children subject to a child protection plan for neglect has doubled in 2025/2026 compared to 2024/25 which is related to the roll out of SCP neglect training and the development and use of the neglect screening tool.

#### Lead and Designated Safeguarding Lead Annual Meeting

The annual meeting of the Lead Safeguarding Partners (LSPs) and Delegated Safeguarding Partners (DSPs) took place on 10/11/26. The LSPs retrospectively signed off the 2023/24 SCP Annual Report and acknowledged the progress within the SCP Annual Report 2024/25. They felt the SCP priorities were right and were in full agreement to the Local Arrangements 2025/26 and for to the need to further develop child exploitation arrangements. The LSPs were updated on the SCP response to the recommendations from the Louise Casey National group-based audit on child sexual exploitation and abuse and on exploration of transitional safeguarding.

#### Voice and Engagement

Voice and engagement activities and impact is a standing agenda item at each meeting of the SCP. Children's Services advised of the development of core questions to ask children to help understand their experiences. There was an update on the NEL independent advocacy service for children which is now delivered as part of the Children's Assurance Partnership and Evaluation Service (having previously been provided by an external organisation). The Integrated Care Board provided an update on the feedback from over 400 children as part of the co-production strategy and the plan to prioritise the recommendations in taking forward voice and engagement.



## Subgroup Progress

Subgroup chairs reported into the board, key highlights included:

- The Safeguarding Practice Thematic Strategic group continue to deliver the neglect, and child sexual abuse strategic delivery plans for 2025/26 and work is underway to develop refreshed ones for 2026/27
- The SCP agreed with the Early Help Strategic Groups' proposal to close down a number of completed actions within the 2024/26 Early Help strategic delivery plan and for a new delivery plan to be developed in April 2026 aligned to the local development of the Families First reforms
- The Child Exploitation Strategic Group are reviewing the child exploitation strategic delivery plan informed by the experiences of child exploitation of local children. The chair of the group has changed from Nicole Elliot to Jim Clough. A child exploitation toolkit is being developed along with child exploitation e-learning training
- The Safeguarding Performance Practice Assurance Group identified exceptions to be reported to the SCP Board based on the analysis of the quarterly SCP Dashboard Report. The group received agency assurance reports which provide assurance how agencies are contributing to the delivery of the SCP priorities, the impact of voice and influence arrangements and any operating issues
- The Safeguarding Practice Learning and Development Group presented a proposal to the SCP on holding a multi-agency session on cultural competency and anti-racist practice to inform practice in this area. The SCP signed the Pretrial Therapeutic Support protocol which has been updated and relaunched on the SCP website. Pre-Trial-Therapeutic-Support-Protocol-December-2025-Final.docx

## Scrutiny and Assurance

A number of reports were received which provide assurance to the SCP which include:

### MARAC Review

Children's Public Health provided an assurance briefing on the Multi Agency Risk Assessment Conference (MARAC) process in respect of domestic abuse. Operational Terrestrial has been launched by the Police in NEL, and the intended outcomes are to reduce the current high referrals, provide an improved service to victims of high-risk domestic abuse and ensure a consistent and multi-agency approach. The domestic abuse needs assessment and domestic abuse strategy are being reviewed and will be presented at a future SCP Board for information and assurance.

### Child Sexual and Child Criminal Exploitation

Assurance was provided to the SCP Board on the local response to national reviews in respect of child exploitation. There will be an independent enquiry on child sexual exploitation into grooming gangs and failure to protect, chaired by Baroness Anne Longfield, which is in response to a key recommendation from Baroness Louise Casey's national audit on group-based child sexual exploitation and abuse. The SCP have implemented a local action plan in response to the national audit recommendations. The experiences of child exploitation of local children will inform the child exploitation strategic delivery plan.

### Children with disabilities and complex health needs living out of area

The SCP received the third assurance report on arrangements for children with disabilities and complex health needs placed out of area based on the National Safeguarding Practice Review Panel report findings. Further assurance will be provided on the collective understanding of children with disabilities and complex health needs placed out of area children and joint working and visiting.



### Childrens Public Health Nursing Review

Children's Public Health Nursing provided detail of the public health nursing strategy developed to ensure a sustainable model of delivery for the mandated Healthy Child programme and to further strengthen safeguarding practices. There is a long-term plan to achieve this and to address recruitment issues including grow your own.

### Integrated Care Board Update

The Integrated Care Board (ICB) provided an update in respect of the ongoing changes as part of the ICB Blueprint which sets out the core functions and strategic role of ICBs. The final structure is being finalised, and the new model will be in place from 01/04/2026. The ICB will remain the lead for safeguarding.



# Communication and Stakeholder Engagement

The following activity has taken place as part of the SCP communication and engagement arrangements

## Child Sexual Exploitation Partnership Development Session

A partnership event was held on the 25 November 2026 to share the views and experiences of some local children who had experienced child exploitation, along with learning from national research in practice. The event was very thought provoking and led to a number of key actions that will inform the SCP child exploitation strategy and local arrangements in responding to child exploitation.

## SCP Local Arrangements Event 15 January 2026

Over 80 people from across the whole partnership attended the event, which celebrated the level and pace of progress and impact made by the partnership in delivering the four SCP priorities, Early Help, Child Exploitation, Neglect and Child Sexual Abuse, through the Local Arrangements and outlined within the Annual Report. - The embedding and consistent use of the Threshold Document leading to an increase in cases held at early help and increase in safeguarding referrals
- Learning from rapid reviews has informed practice through the dissemination of key learning across the partnership
- The SCP Governance structure is actively delivering the SCP priorities
- Independent scrutiny arrangements have provided assurance on the effectiveness of safeguarding arrangements



## Focus on hidden harm of children being sexually and criminally exploited

There was also a key focus on child exploitation from both a national and a local context and in particular the experiences of local children and how this is informing the SCP Child Exploitation Strategic Delivery Plan. Key messages included:

- Understanding the child's experiences and the signs and symptoms of sexual and criminal exploitation
  - The need to avoid victim blaming language, which is any language that implies a child is responsible for the abuse they have experienced. Click on the YouTube logo to view a video

  - The importance of agencies reporting any intelligence which may be an indicator a child is at risk of/ or being exploited. This enables the police to piece the intelligence together across the community. All intelligence **must be shared** with Humberside Police
